Good morning. Good afternoon. Good night. Wherever you are in the world, it is time for HighWire. I've got an amazing show today. We're going to go to the incidents in Harvey and show you a story you have not heard. But first, a story you can't believe. Get this. "Patriots pay refs to attend players 'Info Lunches." So apparently refs made up to \$30,000 per referee. They got travel expenses, trips paid to Tahiti and Ibiza by the New England Patriots, and some of them got contributions to their pensions, up to \$95,000. Now, apparently what was happening here is, I guess during their training camps, coming into the new season, Belichick brings the referees of the NFL in to speak with his players and talk about the rules and give them some tips on how to get in and out of the rules. Belichick is quoted as saying, "I want my players to know ins and outs of the rules. Who better to teach them than the referees themselves?" Think about that. Paying referees. You would imagine that would be illegal. How the heck does that not end up affecting how the game is being judged? And they were asked just that. One of the referees actually said this. "I received a fee, yes...it doesn't affect my decisions on the field. The rules are clear. I'm a professional..." Oh, I'll bet you are. And think about, look at this. They did a private poll.

It was an anonymous poll of the referees in the NFL, and and what they discovered was 95% of refs polled said when they bet on football, they bet on the Patriots. I mean, who wants to be in a team that's not the Patriots? How can someone keep that level of a conflict of interest? You're being paid to be brought in by one team in the league. Every other team is going to go up against that team, you're telling me this isn't affecting your ability to judge and referee a football game? Roger Goodell was asked about this very story. This is what Roger Goodell had to say. "Our internal investigation was unable to identify any violations of the NFL code of conduct." Makes you wonder about the NFL code of conduct, doesn't it? I mean, if you're not sitting in your home right now thinking, are you kidding me? This is unbelievable. I mean, on top of everything else in football, how could this be allowed? People are betting on this game, and to think that there's this type of money being transacted between one team and nobody else's team. I mean, that's a conflict of interest that is beyond belief. That's because you should not believe this, this story did not happen, not in football anyway. I've made it up to make a point, because this is exactly how vaccine safety studies and testing are done every single day in this country.

You would not have referees that are fans of a particular team being paid off by a particular team to do anything like just come in and have an info lunch. You would not allow that because you know it would affect their judgment on refereeing the game. Clearly it would affect one team over the other. I want to make a point that this is exactly our problem with every scientific study being done on vaccines today. The people doing the studies are being paid by the very single industry that is going to make the money on selling the vaccines. I'm going to make this point with a study that just came out, this is a big one this week. Let me find it. Okay, so this was a study that. Oh, I'm getting a page ahead. Here we are. "Risk of recurrence of adverse events following immunization: a systematic review." So essentially, this is one of the points that, we are winning this. We're winning this argument because now at least they're admitting that there are adverse events to and reactions to vaccines. And since so many people are starting to talk about it, they've done a study to say, don't worry if your child was hurt or injured by their first vaccine. Odds are it's not going to happen again. We have a study to prove it. In fact, Richard Pan, if we can pull up Richard Pan, slide number nine here, he touted this study all over the place and said.

"A child who experiences a serious medical event after a vaccine has a very low risk of having another serious event occur after the next vaccine,... 'This article reinforces what vaccinologists and pediatricians have known for many years...'" Really, Richard? Okay, Well, here's my point. We wouldn't let you pay off referees, but are we paying off the people that are doing these studies? I want you to look at this, at the end of this study, look at the conflicts of interest that are reported. This is the potential conflicts that were reported. "Dr. De Serres has received investigator-initiated grants from GlaxoSmithKline and Pfizer...." He's had trips, travel, just like I said with the refs, paid for to ad hoc advisory board meetings of GlaxoSmithKline, and another doctor on the study, Dr. Top "has received in-kind research support from Pfizer and a grant from GlaxoSmithKline." These people, these doctors work for a pharmaceutical company, and then they go and do a study to tell you, don't worry about it if you've been injured by a vaccine, because our study that we are doing, have done shows that even if you've been injured, just go ahead and get your next vaccines because they're safe. Here, if you look into what, it says it right at the top of this study, and this is what, this is the point I want to make. Our scientists in this country and around the world all believe vaccines are the greatest invention of the 20th century.

They will say it all the time. You hear it in the news all the time. They are fans of vaccines, complete and total, devout fans of vaccines. They don't think there is any way to live a life without vaccines. They believe completely and totally, just like referees had they bet, if you found out they were betting 95% of the time on one team, you would say they have a bias. Every single doctor and scientist in this country in the world on this issue has a total and complete bias. So how does a study like this happen? Does a study go, oh, let's look at the adverse events of vaccines and see what happens, and look at all the thousands of studies being done and then come to a conclusion? No. They set out for a very specific conclusion, and they say it right in the top of their study. Here in the top of their study, it says, you can bring this up. "Vaccine recipients who experienced an adverse event following immunization (AEFI)are sometimes afraid that the adverse event might recur with future immunizations, and this can lead to avoidance or delay of subsequent immunizations." Meaning if your child is injured, you're more likely to delay that next stop for their next set of vaccines. Why? Because you have a brain. Because you have instincts. Because you watched your child have an allergic reaction to something.

These include fevers, headaches, sometimes seizures right after the vaccine, apnea, stop breathing. And what they're trying to say is we've done a study to look at this, and they say later in this paragraph, "The aim of this systematic review was to summarize the literature on the risk of adverse events following immunizations and identify predictors of recurrence. In addition" --here it is-- "we sought to determine if the risk of an adverse event following re-immunization was higher in patients who already had the same adverse event as the previous immunization, compared with those who did not. These results..." Get this, here they say it right to you folks. I'm trying, I'm trying to slap you. I need you to wake up now, America. You need to wake up and listen to this. "These results are expected to inform physicians when discussing continuation of immunization with patients who previously experienced an AEFI" --that's an event following an immunization-- "and to support future immunization guidelines for these patients." Essentially, this study is designed to take away the fears of parents to make sure they come back and get their next vaccinations. That's what the study is for. That's what the study set out to do, and who's doing it? A couple of science that worked for GlaxoSmithKline and Pfizer. Wow. So guess what? They got exactly the results they were hoping for.

Is that an accident? That's like saying, guess what? The Patriots, every single fumble and every single pass interference call and every single call at that game all went in favor of the New England Patriots. It couldn't have had anything to do with the fact that the Patriots pay off refs. Now, remember, I'm not saying that happened. Don't quote me on that. It was an example of how we should be looking at this story. So continuing on, here are the facts of the study. They started. So it was not like an official study where they gave kids vaccines and then followed them through their life. They just looked at other people's studies, studies from around the world. They just sort of brought them all together and tried to get the information they wanted. And what they admit in the study is that they started out with 3,659 studies to look at, to cross-reference and see, did people who have adverse events during their first vaccination have them at the second one, at the third one, at the fourth one. By the time they did this study, they narrowed those 3,569 down to the ones they were going to use. 29. They narrowed it down to 29. Why? Because that's how you do a demographic study when you want to show exactly what you're trying to show. They set out with a goal to tell you, don't worry about it, you're safe.

Now, do you think anybody in the studies that they chose died after one of their vaccines? No. Do you think any one of the people that were in the 29 remaining studies got autism right after a vaccine? No way, no how. In fact, they even admit they kicked out a study where people had seizures after the study. Because the focus of the study was all about seizures, they said, we decided to not use that one. So what were they looking at, and what were they looking for? Think about this. If you have an industry that categorically states, SIDS is not caused by vaccines. Autism is not caused by vaccines. Oftentimes, they'll say seizures are not caused by vaccines. So when they say that, you can know that any study that showed that those things were happening after a vaccine were thrown out. They only looked at adverse events that they agreed do happen from vaccines. Do you see how you can manipulate a study when you're paid off by the industry that is going to make money off of this study? Let's go on. It gets worse. I mean, as if narrowing the studies down from 3,529, cherry-picking what you need to say isn't bad enough, they went on and they looked at 594 children and adults that were re-immunized. We are talking from infants to elderly, they looked at inside of this 594, okay. So out of these 3,000 original studies, they got it down to 29 studies, and now we're going to base the entire logic of getting you to refuse to worry about the allergic reaction your child just had down to 594 people.

And it gets worse. Of the 594, only 148 of the people in this study got full doses of vaccines. Most of these studies were giving quarter doses and half doses because they were looking at something totally different that had nothing to do with looking at, do you have an adverse event after getting a vaccine. So they didn't even get 594 people, out of the millions they could have looked at. They got 594 that didn't even receive full vaccines every time they got them, or multiple vaccines. They went with people that got a half a vaccine. Have you ever tried to go to your doctor and get a half a vaccine? It only happens in the study. It only happens in the studies that these paid off liars pointed to. Anyway. That's how you do it. What were they looking at? Like I said, they say, in their own study, the adverse events they were looking at after 20, in the first 24 hours, they looked at rash, respiratory problems, anaphylaxis, bilateral conjunctivitis, and facial edema. After 48 hours, they looked at apnea, anorexia, lethargy, fever, pain, vomiting, and redness. And then after 15 days, they looked at redness at the injection site.

This is what they're looking for in the study. They're not looking for death. They're not looking for SIDS. They're not looking for seizures. None of these were the criteria. They just said, was there redness at the injection site 15 days later, as though that's a horrible reaction. They're not looking at any of the dangerous reactions that parents claim every day. And I really want to make this warning to you. If you think that you want to listen to this type of crap, go to VAXXED.com, v a x x e d.com, and watch every single video you can stand that Polly Tommey's done across this country, Australia, England, and Ireland, where parents will tell you the same story. I did not recognize when my child had a rash the first time they got a vaccine, that that was an injury of any kind. And then when they got their next set of vaccines, they stopped talking. They lost the ability to walk. They lost the ability to communicate or do anything that they were doing. A catastrophic event took place. And had they seen the warning signs, they all say it. I swear, almost, I think over 90% of them looking retrospectively back at the vaccines their kids got said, I should have known better. There was a reaction. They had a fever, they had a seizure, and my doctor said, don't worry, that's normal. My doctor is going to point to a study like this and say, don't worry about it.

Our studies show that you have a less than 1% chance of having another adverse reaction once we've whittled out every study that showed otherwise. This is how it's being done, people. It is a total and complete sham. It's rigged. It is totally rigged. I want to bring up another slide because let's just look beyond this study, I want you to look at all vaccines in general. This is a slide that shows ACIP. Now ACIP is the Advisory Committee on Immunization Practices. Essentially, what ACIP does is after the FDA approves a vaccine to be on the market, ACIP decides whether it goes onto your childhood schedule and gets mandated by the government or not. So think about this. This committee is the one that decides whether this vaccine is going to be forcibly injected into every child in America. Meaning this committee decides whether a vaccine that has been said to be allowed to be injected, whether it will be forcibly injected and paid for to the tune of nearly \$1 billion profit. This committee decides whether Pfizer or Merck or Sanofi-Aventis' new vaccine should make them \$1 billion. So of all the committees you could ever imagine that is going to vote to decide whether the industry itself makes billions of dollars, this is the one that does it. It should be, I mean, am I wrong here? Should it not be totally clear of any vaccine insiders whatsoever? You bet it should.

Can you imagine if you got to vote on whether a product was safe or not and you made the product, and your vote putting the product on the line means you're going to make \$1 billion? Can you imagine being asked, do you want to be on this committee? You're damn right I do. I mean, who would want that job? You mean I get to vote for my own product to make \$1 billion in the US government? That's right. Great. Yeah, hey, I'm in. Who wouldn't do it? And if you think I'm lying, this was an investigation by the Congress of the United States, this is the House Government Reform Committee in 2000 looked at ACIP, and just like I made up about the referees, here, it's real, folks. Here is the real conflict of interest of the members of this committee. One of them was a chairman on Merck's advisory board. Another member shares a patent on a vaccine and has a \$350,000 grant. Another member voting to put these vaccines onto the schedule works in Merck Vaccine Division, received funds from vaccine manufacturer, and is an investigator for that company, oh, is an investigator for GlaxoSmithKline. Members also received a salary and payments from Merck. Another member was participating in vaccine studies with Merck, Wyeth, and SmithKline, and another member received grants from Merck and SmithKline.

This entire committee is packed with the people that are going to make profits off of vaccines, and they're the ones that are telling you, and having Richard Pan tell you, this is what you need for your child's safety. Forget about the fact that we are personally going to make \$1 billion off of it, your child needs it to survive on this planet. I am not making this stuff up, folks. Look at that list. Paid by Merck, trips by Merck. It's worse than anything I made up in the NFL just a second ago. You need to wake up. And this is what's really, really priceless. At the very end of this, the conclusion of this study, says, "Despite vaccines being administered to millions of people annually, there are few studies in which researchers evaluated AEFI" --that's the adverse events from the injection-- "recurrence. Published studies suggest that reimmunization is usually safe. However in these studies, severe cases were often not reimmunized." So even the studies we looked at, if they'd had severe reactions to the first ones, these studies didn't even reimmunize them. So the entire point, and I want to bring up Pan's slide again, can we go back to number nine. Because look at this slide. When he points to, hey, folks, don't worry about the injury to your child. As it turns out, they're perfectly safe. Look at the title of this article.

But the study just said, however, in these studies, severe cases were often not reimmunized. So the studies that were looking at go against what this says at the top of it, they didn't even look at people who had serious reactions. They don't know. Because their studies didn't show it, but Pan doesn't care. He's going to put your child in danger by quoting this totally fraudulent piece of crap put out by industry insiders. Do you see how dangerous this is? We're not even talking about throwing a pigskin around a freaking field, we're talking about your children's health are hanging in with referees that have been paid off. This is the problem I and everybody in the vaccine adverse events honesty world, we want honesty around these adverse events, this is the problem we have. It's rigged. Now, is it their fault that they have conflicts of interest? Is it their fault that they manipulate studies and cut the studies down from 3,000 to 29 that say exactly what they want? No, it's not. Alright, we've all seen this horrific storm unfold on the people of Houston, now it's moved into Louisiana. Devastation like we can't imagine, they're talking \$100 billion in damages. Imagine having to deal with that. Some evacuated, others were told not to evacuate and found themselves stuck in homes, filling with water, hiding on second and third floors of their houses. Others dying, wash away, being washed away in cars. We hear stories about pets being rescued, how difficult to deal with the pets. But imagine if you had a child who's number one propensity was to run towards water and drown, who couldn't handle large rooms full of people, loud noises, smells, could not be in spaces like that, you couldn't even go to a shelter. Imagine taking a horrific situation. You're soaking wet, ice cold, trying to save your family, and you have a child that cannot handle any excess stress or outside interference. That's the story I want to talk about today. And today, I'm going to be talking to Shelley Hendrix, who runs Unlocking Autism. She's on the forefront of trying to help FEMA and our government understand what this issue is like. Shelley, thank you for joining me today.

Can I have a little bit more on the cans. Shelly, just really quickly, what are the main problem, and you've been through floods yourself. This is something you've dealt with, you know, Katrina, you've been around these floods before, but what is it specifically that makes having an autistic child so difficult when you're in a crisis situation and a flood moving into your neighborhood and your home?

Well, it's difficult to be able to <unclear> the situation whenever there's a massive crisis, just in general. It's hard for anybody. But when you have a child with autism, you're already going into the crisis tired and worn out sometimes, your family's not operating at full cylinders as it is. It was really hard with this particular storm very similarly to Hurricane Gustav and Katrina, because they happened right at the end of the month, so people's resources are low. And then when you have a child with autism, a lot of times the disruption of not being able to stay in a similar routine, not being able to provide them with foods that they're used to. Electronics are difficult. Your electricity can be out for weeks and weeks and weeks at a time. And if they're dependent on those sorts of things to be able to function or to be able to communicate, if they use an iPad to communicate, for example, it can make things really difficult. And as you move into sheltered situations, that's where it's really hard for our families. Some of our families choose not to evacuate and they shelter in place or they decide to stay in cars after adverse weather events like this because they feel like that's safer, because large shelters are also difficult to help our children stay calm and keep their behaviors under control and or just, you know, be able to rest and get the sleep that you need to get after an event if you know your child might get up off of their cot and wander away in the middle of thousands of people.

And oftentimes, I mean, one of the major issues, they could wander away. If they get outside, they get into the flood area. I mean, drowning is a major issue with autism, is it not?

It's a huge issue, and our kids are just, they're just, I don't know why they're drawn to water, but they are drawn to water. And when those waters are are high, you can't tell by looking at a flat surface where the roads are, you can't tell if it's going to be six inches deep or if it's going to quickly drop off to three, 4 or 5 feet deep, and so it's easy to wander into bad waters. And, you know, it's just, when something like this happens, you can't imagine the level of distraction. And as people, it's not just during this emergent situation, it's going to be for months to come, our community is going to need to be really hyper vigilant down there in Texas and in southwest Louisiana, because, as you try to go in and gut your home, as you try to do the repairs, you know, doors are open, windows are open. You know, it's easy to turn around and then all of a sudden realize Johnny has slipped out the back of the house, so.

I can't even imagine the stress in that situation. I mean, it's not, you know, when your kids are healthy, you're able to say, stay in this room, just hang out here, play Scrabble, Monopoly. Mommy, daddy's got to go work on the other side of the house. You cannot do that in these situations. And as you said, many of these kids, you know, the iPad tha,t some interacting, you know, technical electric device is what they use. If you don't have electricity, you know, the things they're used to sort of placating them is not even available to you. So your nonprofit is called Unlocking Autism. And so one of the things that you do is that you want people to register if they're in these danger zones, right. If you if you have a child with autism. So where do we go? We go to unlockingautism.com, where's the best place to register your family.

If people go to unlockingautism.org, we've stripped everything down to where it's really focused on Harvey, we've eliminated all of the other pages, so it's just, what we want to do is we want to try to find our families and find people that are impacted so that we can continue to help track you and track your progress. I think a lot of times people don't realize when there's been a situation where there's been just catastrophic devastation, especially in a field as large as what we've seen happen with Hurricane Harvey, it's going to be a rolling situation. People have lost their cars, they've lost their homes. Floodwaters are not discriminatory, it's not like they come up to a business and say, oops, people are going to need to work here in a few days, so we're not going to go in there. I mean, it's devastating. It wipes out businesses, which take away jobs. So you can have a family that hasn't had any wind damage, no flood, and they lose their, you know, means of employment because the business that they, where they worked was destroyed or offline for several months, and that can really impact our families, too. So even if you're not feeling any immediate effects from Hurricane Harvey, it's great to go ahead and register with us just so we can help track and so we can also get an idea of the volume. We know that, I'm a political monster, so I think in congressional districts and in every congressional district that was impacted, we're looking at around 2800 children, just based on CDC standards and population size, for each one of those districts, which is an extraordinary number of families that could be impacted.

And what is the total number would be the guess based on CDC estimates of families with autistic family members that are in harm's way right now?

Right. So this doesn't mean that everybody has sustained damage, this doesn't mean that everybody is impacted in this way, but if you add up those districts, it very quickly adds up to around 64,000 kids at a minimum. Texas is a really big state and this is a really big disaster field where it has hit. And while it's impacting millions and millions of people, we need to realize that that population also includes one out of every 68, minimum, children under the age of 21.

Now, Shelley, you reached out, in fact, you've sort of become, you started this, your group during previous floods and catastrophes like this. I understand that you've sent letters to President Trump, politicians all over Texas and Louisiana, and you're sort of becoming, it sounds like a prominent voice in how to help FEMA and these groups deal with autism because many of these families, am I wrong? They get turned away from these large shelters simply because they aren't able to contain them in areas where they can be and all the issues you described, is that correct?

Well, what we have experienced, we experienced this during Hurricane Katrina, and then we've experienced it in subsequent storms and we saw this definitely happen in the Baton Rouge area during our great flood that we had last year, is that it's kind of a two-fold problem. One is that our families freak out so they don't evacuate to a shelter and they try to deal with the aftermath of things in tool sheds or cars or crammed up in family homes where there's 30 people and they're very nomadic and moving around until they can get settled. And the second thing is we definitely experienced, we definitely had families that when they showed up, and I even went posing as a family, I didn't need to evacuate and stay in a shelter, I had to evacuate but didn't have to stay in a shelter, and asked, you know, where do I go if I have an autism family? And they said, well, we don't take people like that.

Wow. Okay, so if people want to donate, and by the way, you told me you have zero overhead, 100% of every dime penny that comes into Unlocking Autism goes straight to the people. I think sometimes you give out cards, you know, where they can go and buy a toy or something that their child needs. I know that you've also done things like finding hotels or apartments that are not been rented so they can get a space by themselves. So many brilliant things you're doing. If you want to donate to this cause, then again, go to unlockingautism.org where you can donate. I think this is a really important cause. It's not covered by Red Cross, it's not covered by all the places that you would normally donate to. And you're doing amazing work at educating our government and FEMA. I mean, folks, this is one of the problems we have. People will all say, oh, well, autism, we gotta accepted. Of course we do. And, you know, it's part of our society, yes it is, but why aren't we helping? These parents are in need. You just heard over 60,000, maybe 100, up to 100,000 families with autistic children right now are hanging in the lurch with no help. We have more help for golden retrievers, cats, chimpanzees and iguanas than we have for these parents that have either an autistic child or a handicapped child of some kind. This is such an important issue. Shelley, I know that you're actually in discussions all day, very important ones on the phone with contractors and I think it's military and government officials, so I don't want to keep you away from that, but what is it you want to leave people with, what's the most important thing we need to take away when it comes to dealing with autism in these times of crisis?

First of all, we need to find our people and we need to take care of our people because we are good at that. We can fight in our family, but this is a good opportunity for the autism community, regardless of what you think causes it or ways to treat it, this is a good way to help your neighbor, that's living with autism. Number two, if you're in an area where the sun is shining, start building relationships with your political officials because there's natural disasters that can happen anywhere. And in the aftermath of the storm, after Louisiana last year, we did that and we tried to help our state get prepared for this year, and those relationships were really important. And our state, Louisiana, I'm so proud of us. Like we're prepared. Everybody. they ordered, the state stockpiled 500 weighted blankets, 500 noise-canceling headphones, sensory toys. They came up with a plan. If someone presents at a shelter in Louisiana, they'll get them to a hotel as quickly as they can, so they're in a quiet space. And we want to take the lessons that we learned here and help those be applicable in all these other danger zones, because there's another storm that's out there right now, Hurricane Irma, it's expected to be a Category 4. It's, you know, we don't know if it's going to come to the US, but if it's anything like, you know, right after Katrina, three weeks later, Rita slammed into us, and right after Hurricane Gustav, lke slammed into us three weeks later. So, you know, there could be a repeat coming and we want to make sure that our families are prepared and that they're cognizant and that this doesn't happen somewhere else.

What do you say to the skeptics that say there's no reason for you to manipulate the spine of a child?

Go ask that question to all of the moms and the dads who have had chiropractic care for their children change their lives. The proof is really in the results.

Today I have as my guest Doctors Theresa and Stuart Warner, who travel all over the world, literally, talking about chiropractic. You work with children and babies and there's some controversy around that. And but what I want to talk about is the fact that, and I get this a lot because I travel a lot. People say, what am I supposed to do? My pediatrician, you know, they believe in vaccines, and I say fire your pediatrician. Honestly, you know, what else does a pediatrician do other than give vaccines? I mean, that's essentially what they do. Am I putting people at risk if I say fire your pediatrician, what other options are out there?

Well, unless there's an emergency or a crisis, that's probably a pretty good idea if you want to have healthy kids, because under the pediatricians watch and their direct recommendations, every childhood illness has skyrocketed over the last 20 years. 10% of kids have ADHD, asthma has doubled, allergies are rampant, and every other disease is getting worse and worse. So parents are desperately looking for better approaches and solutions and children that grow up in the chiropractic wellness lifestyle, you'd be hard-pressed to find a child that has any of these problems.

Wow, you're right. And that's one of the things I say. I mean, if, you know, and people are like, oh my God, how can you speak out against pediatricians? I mean, the truth is, is under their watch, we now have the sickest nation of kids in the industrialized world, at least one of the top nations of sick kids, and it's the sickest generation of kids we have ever seen in this country. And I mean, that's, so when you look at, I mean, I say to people, just look at what your health was like when you were a kid. We didn't have asthma running rampant. In fact, I only remember one kid with an inhaler. Now, 4 to 5 kids have one in every classroom. ADD/ADHD, childhood cancer, even, I mean like we've never seen. So if you. And another point I always want to make is that honestly, your pediatrician does really two things, they weigh your baby, measure their head, and then they give them vaccines. And the truth is, is if there is a catastrophic emergency, like you pointed out, you're not going to your pediatrician. You're going to call them probably just like you'd call you and you'd say that's a catastrophic issue, get yourself to an emergency room where they can handle that. So pediatricians can't even really deal with really major problems with their patients anyway. So if I leave my pediatrician, do you feel comfortable as chiropractors replacing that position in the life of a family?

Well, as chiropractors, we do play a very vital role in making sure the child's nervous system is functioning at 100% so that they have the best functioning immune system, the best chance at growth and development. So what we do, the services don't duplicate each other. So for those emergency situations, yes, they'll probably refer you somewhere else, but it's good to have the pediatrician as that gatekeeper. But for wellness and looking at maximizing your child's growth development and the opportunity that they have for wellness in their life, the pediatric chiropractor is the person that should be in charge of that and the gatekeeper for that.

Is it dangerous to adjust a baby? I mean, you're, in the in the video that I just watched, I mean, you're adjusting infants. How early into the life of a baby do you feel comfortable making an adjustment?

[00:43:41] Dr. Stuart Warner, Pediatric Chiropractor/Child Wellness Expert

Immediately after birth, because when you recognize the important role the spine and nervous system plays in that baby's health and development, you want to make sure that nervous system is free of interference, and the actual process of birth can cause a lot of stress on that newborn's neck and cause subluxation and misalignment, which interferes with the nervous system. So it is very important for every baby to be checked at birth to make sure that their nervous system is working properly. And it's a misconception that some people have that there is any safety concern with babies because it is 100% safe. And to put the audience at ease or anyone contemplating bringing their baby to the chiropractor, you know, our malpractice rates are a fraction, a tiny fraction of what other doctors pay because what we do is safe. And in 115 years of the chiropractic profession and hundreds of millions of adjustments made, there aren't any studies that show harm to a child from a chiropractic adjustment. So if you compare the amount of force used in the birth process where there will be 20 to 40 pounds of torsion and traction on that newborn's neck to deliver it, and you compare that to a couple of ounces or a pound of carefully directed pressure in the right place at the right time, there's no comparison, it's completely safe, gentle, and it's completely necessary. So if you want to have a little metaphor to see the amount of pressure that's used it'd be if you're checking a ripe tomato and you know that's the right amount of pressure in the right direction at the right time to restore alignment and function, to remove nerve interference, and then that child is going to have the advantage, no matter what they do in life, if it's work, sports, school, relationships, to go through life with a nervous system free of interference so they can be the best they can be.

Explain that to me. So how, and this is something that honestly is new to me. I mean, I, you know, I told you before we did the show, I only went to chiropractors as a kid when I would have a sports injury, I'd wipe out really hard on my skis, my knee would be all out of whack or something like that. My mom would say, well let's take you to the chiropractor. I was never aware that there was actually something about, you know, other than just my spinal alignment or my bones alignment. How is it that just adjusting a baby's spine can affect their nervous system? How does that work?

Well, it works the same way that it would, very similarly to an adult. So as we're making that correction, if there is misalignment in the spine or the joints aren't moving properly, it can cause irritation of the nerves. And wherever that nerve's going to, it needs to connect properly with the brain, and it can cause interference. Think of it like static in the system and the messages won't get through the way they should. So for an example, if you took a light bulb hooked up to a dimmer switch and we should be all functioning as bright light bulbs right at 100% function.

All the electricity, making it to that....

[00:46:51] Dr. Theresa Warner, D.C., Pediatric Chiropractor/Child Wellness Expert

All of the electricity making it to and from the brain, constantly sending those messages all around. But we have a fall. We have to carry a heavy backpack to and from school. We have pollution coming into the body. We look at three causes of subluxation or this nervous system interference: physical stresses, chemical stresses, and emotional psychological stresses. They all affect the nervous system the same way. And kids suffer that equally to adults, they have a lot of stresses. And so if we take that dimmer switch with each one of those stresses, little by little, we lower it a little more, a little more, a little more. And all of a sudden people are walking around and they're at 60% or 50% and they all of a sudden become numb to it and they think that's normal. And so they have a child, and now it's become normal that kids will have colic or reflux or ear infections, and then they'll develop asthma and allergies and chronic conditions. Well, we're here to say, folks, that's not normal. God didn't intend for our kids to be sick all the time. We should all be turning up the dimmer switch. We want to be functioning at 100% and give our bodies the greatest potential to express that throughout our life. Although every child's potential may be slightly different, we want to maximize their potential to be, do, and have all that they can.

Now, I can understand how your nerves literally run through your, you know, your spinal column. I can understand how your nervous system can be affected by that. But you just said pollutants, you know, emotional stress. How does chiropractic do anything for that? I mean, if I'm eating, breathing toxic air, water, food, does chiropractic get involved with that, and how would it affect that?

[00:48:44] Dr. Stuart Warner, Pediatric Chiropractor/Child Wellness Expert

Yes, absolutely. It's called a somatic visceral effect, so if you're breathing in toxic air or you're eating toxic food, that's going to affect the nerves that go back to that area of the spine. And the one principle that we rely on as chiropractors is your body knows how to heal itself. It is programed to heal itself, it's always striving to heal itself, and the brain and nervous system is what controls how the body heals. It controls the immune system, controls the biochemistry. So if there's any interference in that system, it's going to create a vulnerability and make that child more susceptible to all types of illness and problems. So it is vital that every child get checked for subluxation and remove that interference so their body can have the best chance possible to overcome any challenge that they face. And chiropractic removes that stress to allow the body to work the best it can.

So ear infection's is a huge thing. I mean, I think that, you know, my kids have had ear infections. I think everybody goes through that, it seems like, you know, I you know, for me, I found that, you know, a couple drops of colloidal silver work great on our son. I don't even know how that works. I just know someone said, try it, and he's never had an ear infection last more than a day. But if someone has a ear infection in their child, would you recommend, do you want to have them brought into your practice? Is that something you should do, is that, is that?

Absolutely. You know, we want all children ideally being seen on a regular basis to maximize their potential. But all these types of symptoms that kids have, parents will readily report back, millions of parents, that these conditions have improved under chiropractic care. And so the proof is in the patients, that time and time again, they'll say, we've tried everything. We went to the pediatrician, we've tried numerous doses of antibiotics. We went to the specialists. They put in a set of tubes, they fell out. What do we do, doc, we were referred to you? And we start getting adjusted, release the pressure, the nerve pressure in that upper neck. Gentle, we call it the adjustment, gently adjust the neck, remove that pressure. What happens is there's misalignment up in there. It causes nerve pressure and interference. It'll spasm those muscles and block the lymphatic drainage, so the fluid pools. And it's a simple concept, the fluid pools, it becomes a breeding ground for bacteria. So if all you do is a temporary correction and just put some drops in the ears but leave the underlying cause there, you'll need dose after dose of antibiotics and nothing will work. But we remove that underlying cause, remove the subluxation, remove the stress ,and allow the body to heal itself and to work better.

Alright, let me jump on the other side here, just a little bit, because I am a fan of chiropractic, especially since after having made VAXXED, you know, your community has been very supportive of the issues that I speak about all the time. I always say that I can tell chiropractors in the audience or when they're coming up because you're radiant, you glow, your children just are like these light bulbs. But I do, I will, I will admit to you, I have concerns. I grew up with some chiropractic, but there are things that I can't get out of my head, like if I'm popping, you know, if I'm being adjusted all the time, isn't it making it easier for me to go back out of adjustment? I mean, it's like anything, if you keep doing this with a nut and a screw, eventually, isn't it going to loosen up where I kind of want more tension?

Yeah, that's a great question. When we evaluate the spine, we're looking for the areas that are in alignment, ones that are stuck or misaligned, and ones that are moving extra. So we're not going to be adjusting the areas that are moving normally and are healthy. We're only adjusting the areas that need it, that are misaligned. And we're also looking at patterns. The patient comes to us with orthopedic, neurological, and postural habit patterns, so it takes repetition and consistency with the adjustments to change those patterns so the brain and nervous system can recognize the new patterns and we can train the muscles and the ligaments to hold the spine in its proper position. Each adjustment builds on the next. So according to the chiropractors technique, you know, they'll determine how many adjustments that are needed, but under no circumstances should people be, you know, manipulating themselves. You know, the doctor of chiropractic will perform a specific adjustment in the right time, in the right place to have optimum health.

Okay. The other gigantic fear, we actually, when I was on The Doctors with Travis, who I was, you know, is a great doctor and I had a great time working with him. But his concern, he would never get his neck adjusted. He always said, you know, the rest of his body. And we did a story about a guy who got an adjustment and then some time later had a stroke, that it somehow released, you know, an aneurysm or something like that. That's the, I mean, you hear about that fear. Is that a legitimate concern?

[00:53:52] Dr. Stuart Warner, Pediatric Chiropractor/Child Wellness Expert

Well, it can be a concern if not done appropriately, but doctors of chiropractic are trained so that doesn't happen, and if you look at the statistics, the incidence of stroke is actually lower in the chiropractic population. So they will do the necessary history in evaluation to rule out any possible risk factors, but also many of the sensationalized reports that we've seen on television weren't even done by chiropractors, they're done by physical therapists or massage therapists or even something that might have happened in, you know, getting a haircut. So, you know, it's extremely safe. It's important for the neck to be in alignment, to have the vascular system have proper flexibility and movement, so it's very safe for the neck to be adjusted, so necessary.

So you probably do both. I would guess that you have clients that both have a pediatrician, get vaccinated, and use this as a complementary approach to the health of their children, and then also, I would guess that don't vaccinate at all and use you primarily. Do you see a difference in the kids that come into your practice?

We see a big difference, but we also have a lot of medical doctors, pediatricians, obstetricians, surgeons that bring their children to us as well. So they recognize the benefits.

Yeah, absolutely. You know, the parents notice it. We do a lot too to try to get the moms in touch with other moms, and so, and parents, in touch with other parents, so forming that community so that they're able to share that and see. And so many parents that started on what we think of in this country is more of a traditional road to to raising their kids within that medical model, enter in and they meet other parents who have made these different choice,s that maybe had a natural birth or a home birth, who are breastfeeding their kids, who are eating an organic diet, who are receiving regular chiropractic care to optimize their child's spine and nervous system and health and development. And so they see those kids, they hear the stories and the shifts that these parents take, and it helps them to navigate the waters. You know, these are big decisions. And so many parents out there, I, like you, have heard, just far too many stories of regret. If I had only known then what I know now. I wish I had known. Moms think they don't have a choice. They think they don't have a voice. They don't know that their concerns even matter. And many times if they voice those concerns at the pediatrician's office, at some medical office, they're put down, they're pooh poohed, or they're kicked out of the office. We want to say, mom, you have a choice. You have a voice. Here's the research. Do your due diligence, make your decisions. And here's a network of other moms, we actually hold wellness moms meetings at our office, so that they can have a network of moms to turn to and find out what options do I have and what's the outcome and probability if I make different decisions. And so then they can make educated, wise decisions and not have to live their life in regret.

Del, what you mentioned earlier about the sickest generation, I mean, it's gotten so bad that so many parents today don't even know there's an opportunity for good health for their children because all their friends' kids are sick and on drugs, and that's become the new normal. So we really need to educate them and let them know that there are options not to vaccinate and to eat certain foods and to get their spines checked and they, the normal state of our children's bodies should be health, and that's what we want to help them achieve.

Well, I honestly, when I'm out there, and a lot of people, because VAXXED, I think, is sort of an entry level look into vaccination and health with children, the people will come up and say, I don't even, where do I start? And I say, find your local chiropractor, you know, because even if you, you know, you can decide whether you want to get into constant chiropractic. You know, you, as you pointed out, that's where you're going to meet other people that are doing things a different way. They're looking at their diet at different way. They're making different choices and they're at different levels. You're not, I mean, I think people, some people think chiropractic is an extremist thing. You know, I know that, I'm sure you don't turn away people that vaccinate. What do you think, though? Do you see, I mean, honestly, of the kids that come in that are vaccinated and the ones that don't, do you see is, what are the types of things that you would see that are different?

There's a big difference. Their complexion, their eyes, their, how they focus. You know, we see the kids that, you know, in the classroom or in karate class or wherever they go, they're so distracted and they can't focus when they're in the vaccinated population, but the children that grow up getting adjusted and breastfed and, you know, doing more of the wellness lifestyle, those kids are present time, they can focus, they're healthy, and they achieve more in school as well. So there's a big difference. And the children that are vaccinated, you know, they need chiropractic more than ever to help overcome their challenges, and on the other side, every child, no matter who they are, there's potential for more health, more well-being, a stronger immune system, better brain function. So to have a nervous system free of interference allows them to achieve their optimum genetic potential on every level of their existence. So we want to give every child that opportunity. Our three children were raised that way since birth, and they're at 100% health and our patients and now we're the last 20 years all over the world bringing these strategies so every child can have that same advantage.

I'm sure there's so much to, you know, people have to find that chiropractor near them and begin this journey, but are you concerned about chiropractic as a profession? You know, you see them attacking homeopathy and, you know, and even chiropractic, they'll talk about how dangerous it is, you shouldn't put your kid in this. Are you concerned, speaking out, traveling around the way you are of the state of this nation and where this discussion is going?

And like you, we've seen too many parents that have been at the negative end of that. And so we want to preserve people's freedoms and right to choice and knowing that they have those different opportunities. So I think it's a better time than any for all of us to speak out. And as chiropractors, you know, we've had an uphill battle traditionally in the media because media is controlled by big Pharma, like it or <audio briefly cuts out> andso you don't see, you know, chiropractors featured in all the tv shows and with talk shows and all these things, you don't see us, you know, them doing commercials for chiropractic and how to maximize your child's health. We see drug commercials all the time and we see segments about that. We may never have billions of dollars to be all over network tv because we don't have the drug company money to support that. But now through social media, we have an opportunity to get the message out to all of the parents of the chiropractic message of health and wellness and opportunity for their kids, if they have a clear nervous system and how that works and why that's important. And so I think that we have an opportunity now to level the playing field in a way like we've never had before. And so more and more people can get out, tell that message. I think it will, we'll be better for it.

Now, just to remind those of you that are brand new, vaxhole is not necessarily a derogatory term, I'm not trying to call anyone a major name. The risks from not being vaccinated include deafness and mental retardation from Haemophilus influenzae type b #meningitis, birth defects from #rubella, cirrhosis and liver #cancer from #hepatitis B and death from #measles." So remember what a Vaxhole is, someone who quotes vaccine safety science that does not exist. This is what the IOM actually, so the Institute of Medicine is a group of our top scientists in the country that look at our vaccine safety studies and science, and this is what they told us in 2013 after looking at all the studies done by CDC and everybody else, this is what they said.
