Good morning, good afternoon, good evening. Wherever you are out there in the world, it's time for us all to step out onto the Highwire. The world just keeps changing around me. I was actually in a meeting, and all of a sudden it popped up that a major newspaper wanted to ask me about the breaking story, that the FDA was suddenly going to do placebo trials. I'll talk to you about Novavax, if I could. It's protein based Covid vaccine. You were an enthusiast for back in Covid. It's target date for permanent approval. As I understand it was April 1st. That's now been delayed. Why was it delayed? And if you'd be so kind? What role did your special assistant, Tracy Beth Hoeg, play in that process?

Well, first of all, major, good to be with you. And yes, you're right. I have been enthusiastic about non mRNA Covid vaccines to help with people who have a tough time with mRNA vaccines. I felt that it could increase vaccination rates. The last study that we have showing that it has a clinical benefit was from 2020 and 2021, and it excluded people with prior Covid infection. Now, essentially everyone has natural immunity. So it's my general feeling, not with this particular product, which I can't discuss in depth, but with drugs in general, that we need to know if they work today in order to be able to recommend them. So we are asking some companies in general to do clinical studies of basic clinical study so we can educate the population and have information to work with. Should a 12 year old thin, healthy girl get a seventh Covid shot this year? I don't know the answer to that because we don't have good clinical data. We can get that data.

And what about Tracy Beth Hoeg? What role did she play in this evaluation process?

Doctor Hoeg is an amazing md-phd who has joined my staff as a special assistant to the commissioner, and she is involved in reviewing data sets at the agency, and I'm really excited to have her in the process.

And she'll be involved in other approval procedures, I gather.

She's an amazing, talented MD-PHD and we're lucky to have her. And that is our job at the FDA to review data. I'm a science guy. I come from Johns Hopkins. I've published 300 scientific, peer reviewed studies in my career. And so you're going to see gold standard science and common sense as two themes in this new FDA.

And for Covid shots for next winter generally. Is the FDA still planning to approve updates to those?

We're taking a look. I can't comment on any particular application. As you know, we have a bunch of applications for those booster shots. Remember, major, 85% of American health care workers said no to the last Covid booster. So we have a bit of a public trust problem. I think there's a void of data. And I think rather than allow that void to be filled with opinions, I'd like to see some good data.

I love this clip. I mean, obviously Marty is doing a beautiful job to weave and stay away from bias, but just say, hey, these products that people are taking, we're no longer just going to blanket say that they're okay. We want a reevaluation. Should a child be getting another Covid shot, after all the years that have gone by. What happens about, if we all have herd immunity, we've already caught this thing. Does no one ever test the vaccine amongst those that really already had infections? So you can see that they're forcing all of the industry to go back to the drawing boards and of course, spend lots of pushback on the idea of placebos. And this move to just complete net zero, shutting down all industry in the name of of climate change. Well, that second part is really also along with WEF is also falling. It seems like. At least it's getting a pause and a breath of fresh air for people to really reanalyze this throughout the European Union right now. This is the headline. They're proposing "looser rules for automakers CO2 emissions targets." This is in Reuters. So they said automakers have to have these emissions targets. You have to switch over to electric vehicles. They're saying no, let's back that off a little bit. We didn't really mean that. We'll give you about three more years for that. And so we can talk about it. Even in the UK they're relaxing their electric car rules. There's a mandate there to switch over, like California had to switch over to electric cars. All electric. That's not happening. And even down to the individual house level, how you heat your house in the UK, they were going to ban wood stoves for new homes. They stopped that major U-turn on wood burning stove ban. This is stunning. Homeowners and campaigners, obviously just the campaigners who wanted to ban those stoves. But this bigger idea, this this, um, this climate change idea that it's people's fault is, is really being questioned now.

And you're seeing a lot of the media starting to push back the corporate media pushing back. Here's a headline out of the Guardian "activate climate silent majority to supercharge action, experts say." You go into this article and it's saying there's this silent majority that no one can hear, but trust us, they're there and they need to activate and and supercharge this action and really push us over the line so the planet doesn't heat by two degrees, and maybe we won't breathe as much and that will happen. But what's really dangerous here is Del. You and I have reported on all these kind of overlay ideas, these masks that are used to sponsor censorship, whether it be hate speech or online safety or just plain old information, public health, any of these ideas, this mask comes in and said, because of this, we need to censor your speech. We need to tell you what you can say and what you can't say. Well, now that mask has changed and it's a climate mask. So we have this idea, this this basically a trust. It's an outside of a government trust called Impress in the UK. And they're reporting that the climate news, the news you and I are talking about right now and reporting it needs to be boosted by independent regulation.

(Yet)" goes into this article it says "UK press regulator impress calls for regulation akin to defamation and libel, where individuals can lodge complaints against news publishers for climate mis and disinformation." And it goes on even further. "Impress plans to launch an ethical content training program to accredit journalists." Remember, you can't report unless we tell you you're accredited "to Accountable Industry Standards and invites climate related news publishers to join as regulated members." It invites them to join. Soon. It will be mandated if they get their way. And how does the crack team at impress vet their articles? This this arbiter of truth? Well, you can go into this headline here and it says "we use a generative AI tool called AI to assist with summarizing parts of the research before it was edited by a human." So apparently that type of reporting is okay. Um, but I don't know, regular reporting like we're doing needs to be accredited and labeled, and you have to go through a reeducation class in order to speak the truth they want you to speak.

And this climate conversation has so many offshoots. And one of them is what we reported on last week, the geoengineering aspect of it. And so in the UK, the UK government is actually it made headlines last week, really just viral all over the place with this headline "Experiments to Dim the sun will be approved within weeks," and this was approved by the Advanced Research and Invention Agency, that is, that was determined by Parliament. It was created by Parliament. It's kind of a research and development agency within the UK government. It's interesting because it sounds quite a bit like the Advanced Research Projects Agency for defense, DARPA out of the United States. It's very interesting. The acronym goes along with that. So that's happening in the UK. But here in the US we have Harvard. Harvard was kind of the main hub to really run some of these programs, or at least research these programs. One of the key players there is a professor at Harvard, David Keith. He caught the New York Times, I with a with a handful of articles. One of them was this this scientist, David Keith, has a r"isky plan to cool the Earth." There's growing interest. That was in 2024. Bill gates funded this venture and it was called Scopex. Basically, it's like Stratosphere stratospheric controlled perturbation experiment. It's a big handful of words there, but launched by Harvard, funded by Bill gates. And you can see here we have over ten years ago, we have David Keith talking, kind of just pontificating at a public event about geoengineering and the risks. Take a listen.

Can I leap in? This is a really important moral point. So if I made a decision or if there was a collective decision to do a geoengineering program and you put, say, the kind of program I think makes more sense to put about a million tons a year in, but let's say you might end up killing many tens of thousands of people a year as a direct result of that decision. I think that has moral consequences. I don't sweep it under the rug. This is a case where I take this much differently from Alan and think it's a much more serious issue. Now, it's true that as part of doing that, you would hope that the overall benefits of human mortality would be so that you would save many, many more people than that. But the fact that you would save more people than you killed. Doesn't mean there's no moral impact of making a decision that directly kills people. And I think that we who talk about this have a duty to be clear eyed about the the direct risks involved in doing it.

I don't know, maybe that's more chilling than the new head of the WEF. I'm not sure. Jefferey you're really you're making this a tough coin toss today. So this guy, I'm being really honest with you. We may have to kill tens of thousands of people every year in order to do the proper climate science that we need to do. I think we have to think about that. Of course, we'll move on, and we can definitely show through our own shady science that we've used throughout Covid and every other debacle we've ever created, that we're actually saving lives, just like the Covid vaccine has saved lives. Forget about all the children dropping with heart attacks on the football field. And it's wonderful Keith is being transparent there and speaking about that publicly. It's also wonderful. He's talking about the moral aspect of this and putting that on the on the map. But what like you said, what if there's parts of climate science that can't be modeled with our current modeling right now? What if we don't understand how the sun works? What if there's a lot of what ifs here when he's talking about, do the benefits outweigh the risk and the risks are just killing people? And if we greenlight that, off they go. That's a big conversation there. And so that venture was shut down in 2024. So David Keith, Harvard's venture completely dead "David Keith's Scopex engineering program is dead." That was March 2024. But this is a learning experience here because just like Klaus Schwab, he's out Nestle guy in. And then we have the Harvard Bill gates venture shuts down. A year later, it pops up in the UK. This stuff is always going on. It's more about the idea and the actions that are taking place. There'll always be new heads that we have to focus on, but it's not about the head, it's about what these actions are moving forward. And so here in the US, this is a big week. We have our government now speaking like this.

My name is Emily. And my biggest concern is the stratospheric aerosol injections that are continuously peppered on us every day. Um bromium aluminum strontium. It's sprayed in our skies all day long.

That is is not happening in my agency. You know we don't do that. It's done, we think, by DARPA. And a lot of it now is coming out of the jet fuel. So, you know, those materials are put in jet fuel. We I'm going to do everything in my power to stop it. We're bringing on somebody who's going to think only about that. Find out who's doing that and holding them accountable.

Wow. Fantastic. Fantastic to be seeing government officials finally taking this seriously.

Yeah. And it goes beyond government officials because arguably, the way the United States is set up, the states have even more power than the federal government. So we have Florida just this week. "Florida makes history" becoming the "first state to criminalize geoengineering and weather modification." So the law, the new law that is going to be signed, is going to make it a felony crime to engage in this geoengineering. Five years in prison, up to five years in prison, \$100,000 fine. It passed the house in Florida by an 82 to 28 vote.

So this wasn't bipartisan right down the middle. Just by just by an inch. This was overwhelming. Essentially, there's 34 other states exploring this type of legislation. And this in Florida was was mainly a grassroots push. The people spoke up. You know, there's always a big conversation is how do we get them to change that up there? Well, the people are starting to do that. They've they've spoken from the Earth to change the sky, essentially. So that's an important move in a grassroots move that's happening in Florida.

And one we've really been directly involved in. ICAN. We've done several shows on geoengineering, on chemtrails, on, injecting sulfur dioxide and things into the stratosphere. We see the balloon company that's doing that private company now being investigated by Lee Zeldin. We've covered that. But I just really want to say, because I don't think a lot of times we sit here, we look up in the sky and we just think, there's nothing that can be done. There's there's no way, the government is just so powerful. I also want people to know that there are sponsors out there of this show, and people that have cared, that really do make a difference in this world. I think a lot of times we think the government is the only way. This is why I'm getting away from some socialist idea that the government needs to protect us. Now we have changed that lens and we're focused on the companies, the safety of their products. This is a good place to be in the UK. Moderna is under the microscope. This is the headline here. "Moderna faces suspension over Covid jab breaches." It goes into this article. It says "if found to be lacking adequate compliance systems, Moderna could ultimately be suspended or expelled from the Association of the British Pharmaceutical Industry. It follows several code breaches, including representatives of the company offering children 1,500 pounds in teddy bears to take part in Covid vaccine trials." Treacherous stuff, it goes on, "says Molly Kingsley, the founder of US for them, said many of the previous judgments against Moderna have revealed how readily it put profit ahead of the health and safety of children. Now, it has also laid bare just how little regard it has had for the regulatory system that was supposed to keep it honest." So let's talk about the regulatory systems that are spooks. Keep them honest, because a lot's happening in the United States this week. And we go to the FDA here. Doctor Marty Makary has made some bold statements regarding vaccine development. Also vaccine approval. And I want to go through a quick media literacy exercise for our viewers here. I want to show you three articles on this reporting on the same story. We go from low, mild temperature. Wall Street Journal. Just the facts. Here's the headline "FDA asked vaccine maker to complete new clinical trial for delayed Covid shot." So basically just go back to the drawing board. We need some extra data. Then we go to Stat News. We're going to turn up the heat a little bit. Stat news says "US health officials inject new uncertainty into approval process for Covid boosters," STAT News writes. "In the process.

They have to be safety tested. What uncertainty? Yeah. Go ahead, go ahead.

Uh, "Makary spokesperson, spokesman of the Department of Health and Human Services, appears to raise the specter that going forward, manufacturers of Covid vaccines might have to generate new effectiveness data before the release of annual updates of their vaccines, a hurdle that would be unlikely to clear to vaccinate people in time to protect them from Covid transmission when Covid transmission is occurring." That's interesting. So I remember reporting that these shots don't stop transmission. But okay, let's just keep talking about that. Then we go to CNN, uh, one of our favorite organizations, and you can count on them for this type of headline. "Anti-vaccine sentiments may derail vaccines already awaiting FDA approval, experts fear." So what happened here? Well, Novavax.

Sounds like a game of telephone where it just keeps getting uglier and worse with each person that answers the call.

Right? And so just to paint this picture more accurately, Novavax, a vaccine company, had a Covid vaccine in the pipeline. It was going through development, it was supposed to be greenlit. And Marty Makary did this. He took the X and said this. "To be clear, this is a new product that Novavax is trying to introduce to the market with a study of a different product from 2021. New products require new clinical clinical studies. Under this administration, we are prioritizing the gold standard of science, not what saves pharma companies tens of millions of dollars" because they were complaining. Novavax was complaining. It's going to cost us so much more money to go back to the drawing board. And what happened was they were putting forward a study that excluded. It was from 2021 that excluded people with natural immunity to Covid. They said, we don't want those people. We just want these these naive Covid people that have never been exposed to this to test our product on now,

Everyone has natural immunity. So Makary is basically saying, I want this tested with the real population that will be taking this if they take it. And it's interesting because I remember people. 2020, Mother Jones, the publication. This was the headline in 2020. Look how far we've come. "Anti-vaxxers have a dangerous theory called natural immunity. Now it's going mainstream." Went so far mainstream that everyone has it now. So that's where we're at. And okay, moving from the Covid shots that are coming down the development pipeline. So the Covid shots that are already approved, a lot of the public has concerns about these shots that are still being given to children, to babies and on the CDC schedule. Well, RFK Jr was speaking with Doctor Phil at a town hall meeting and he said this. Take a listen.

Marty Makary, you're recently appointed director of the FDA, recently said that he was looking at removing the Covid 19 shot from the CDC Vaccine schedule for infants. Uh, I believe he said that last week. And I'm interested in your opinion and if any other changes should be made in the CDC schedule.

I think that is a, you know, I that's something that we're talking about. And I think the the justification for, uh, for giving this shot to children is very, very weak. And particularly since there was the the safety testing is utterly inadequate and children are almost a zero risk or for Covid and the and we're seeing a lot of adverse events from the vaccine, particularly in children of myocarditis, pericarditis, even strokes. And uh, people are trusting us to American people are trusting us to make a good risk benefit judgment when we recommend these products, and we need to go back and look at that recommendation. We're doing that right now. We're waiting for the Senate to confirm my CDC and my general counsel, my deputy secretary of a critical position, and many, many other positions and, you know, and work. We've kind of got our hands tied with these agencies to do the kind of fast action that I would like to see. And then we're way behind on the science. And I don't want to do action until I have solid science behind me. And that's, you know, one of the things that's going to slow this down, but we're going to do it quicker than anybody imagined.

It's really, I think a very important, first of all, to see again, an HHS secretary that is fielding questions about the potential of pulling back a recommendation on a vaccine. I want to say here that, you know, obviously, this is a top issue for ICAN. It's been the focus of the work that we've done. And I'm as frustrated as I know you are. Jefferey and many out there that it's taking so long to get this Covid vaccine away from our kids, get it off the recommended schedule. But I think that second clip, which must have come from a another commercial, I mean, from another question, I think he's laying out what we have to understand. And I've said it too, we don't want this to just be a sand painting that blows away. As soon as, Robert Kennedy moves on to the Trump administration is done and we go back to business as usual, because just some crazy person came in and started wiping vaccines off the schedule. What he's saying is so important, and I think you have to recognize for the most part, our government doesn't just trust science around the world and say, hey, because of, some study out in Switzerland, we're going to change our vaccine schedule. What they see is they call that a signal.

And so obviously you've got the government right now. Certainly Democrats are stonewalling Robert Kennedy Jr. Not just getting him confirmed, not getting all the people around him, which is terrible. We've reported on it looks like they've destroyed the VSD. The Vaccine Safety Datalink was the database of 10 million people that we could have. We could have had answers to autism by right now. By by now, we would have had it. But they're just obfuscating. They're cheating. They're lying. I think they're breaking the law. Robert Kennedy Jr is in the middle of it. But I think at that point, as he's saying, he needs to get the studies going. He's going to get them going. We're all chomping at the bit every single day. Another child is injured. People are dying still. And it's you know, it sucks that it's going to take time. But I think it's important, you know, acknowledge that that's a part of the process, you know.

And there's two moving parts to that that you just illustrated. Because what we saw with Peter Marks is the injured, the people that were injured by the Covid vaccine. There is a critical mass of people we don't know that number. Then there's the people still being the children, still being injected with this vaccine. Those are two moving parts. If the recommendation down the road is removed in June, like they're saying, that may be for children, that does nothing to the liability or the compensation ability for people to get compensation for their injuries or deaths from the vaccine. The vaccine is the vaccine is protected by the Prep act, which Biden renewed until 2029. So that is not going to put this vaccine and put people injured by this vaccine into the vaccine injury compensation program. It's still all going to the countermeasures injury compensation program. Black hole. Very few people get compensated. So still, there's a big question with that conversation too, is where do the injured go? How do they get compensation? Recommendation or not is not going to make a difference here.

Actually, by winning one case, can we open up protections for a vast group of people? This is one of those cases. It was perfectly designed. It had all of the right elements to it. And so we know by supporting a case like that, when we win, we actually open the floodgates. And that's exactly what happened. We won so resoundingly that the government has to decide. We don't want to be in that case. We can't win that again. And so you start seeing changes in how people can come in, immigrate into America and not have to worry about that, mandatory forced vaccines. Canada first introduced medical assistance in dying or MAID, where medics can help people end their life in 2016. At the time, it was only open to those whose natural death was reasonably foreseeable.

Last year, made accounted for 3.3% of all deaths in Canada, or 10,064 people. That's a 32.4% increase over the year before.

Opponents have made argue it's being used as an alternative to social or medical support. Ramona Coelho, a family doctor, says it's far quicker to get aid in dying than specialist care.

Mother of three Rose Findlay is applying for a medically assisted death. She filled out the forms and is counting down to the day she can access MAID. But what Findlay says she really wants is access to services.

It's always been a challenge to find adequate personal care support.

**[00:51:51] Helen Long, Dying with Dignity**

The fact that people are feeling compelled to apply for Maid or to to even ask about Maid because they can't get the basic fundamentals to live a life is it's a shameful.

In March, it's further expanding eligibility to include people with mental disorders. It's expected Maid will be about 4% of all deaths in this country.

When people have suicidal ideations, we used to meet them with counseling and care. And yet now we are seeing that as an appropriate request to die and ending their lives very quickly.

It sends a culturally and socially acceptable message that suicide is one option to end one's suffering, and that is contrary to our message that we're sending to our youth.

It seems to me that offering death to people in the moments of greatest vulnerability fragility is profoundly unethical. I have a patient. I'm in the middle of treatment, the middle of medication trials, and the family doctor came along and kindly, you know, from her perspective offered, made the patient said, yeah, why don't I just die?

This is honestly one of the craziest stories and we've lightly covered it. But I was just up in Canada just over a month ago, testifying in front of a tribunal on many of the stuff that many things that I understand around vaccines. And I ran into the executive director of Delta Hospice Society, um, Angelina Ireland, and she started telling me what's really going on up there. And it was so shocking. And I am just, just so happy to be able to say she's right here in studio to tell you what she was telling me.

Hi, Del. Thank you so much for having me.

Thank you for coming. I said to you the moment we were talking, you're like, I'd love to have this get this issue out there. And I said, we're on it. And so just a couple of weeks later, here you are. When I watched that, that montage of news coming from Canada, and obviously there's some pushback from different people, it almost feels like your government is giddy about rushing in, where anyone might have a weak moment and think about committing suicide. They want to be there to get it done. Before you think twice before you have a moment to back out. Is that am I overstating that?

No. No you're not. This is the Canadian cull. That's what this is.

Yes, culling. You know, listen, Maid is actually an amendment to the Criminal Code of Canada that says that doctors and nurse practitioners can non culpable homicide their patients period.

They homicide their patient.

Non culpable homicide.

**[00:54:35] Del Bigtree**

Wow. So not they're in trouble for it. Wow.

**[00:54:37] Angelina Ireland, President of the Delta Hospice Society**

That's right. And they push it down onto the provinces. And because health care in Canada is a provincial jurisdiction according to our constitution. Okay. They said now the provinces can, you know, get this whole thing going. And that's what we've seen. So the province where I live, British Columbia, they just attacked this with an alacrity, with an enthusiasm. And, you know, I now, look, I'm not a doctor or a nurse.

I'm a patient, right? I'm a cancer survivor.

Thanks be to God. Yeah. And, you know, so I was a patient at the Delta Hospice Society going through my cancer journey. And when I got to good health, um, I joined the board of directors just at the time when they were pushing, MAID, uh, down onto everybody who gets public money.

Okay. So any any company that gets public money.

Well, it's a public health care system. Everybody gets public money.

So. So everyone's on it.

Everybody's getting public money.

So it's everybody.

It's everybody.

Wow.

So we, uh, we did have a public partner partnership, public private partnership with the Fraser Health Authority.

Okay.

And we were told in our hospice. So I became the president of the Delta Hospice Society. And we were told, because we had a hospice that we operated a facility that we actually built. We fundraised \$8 million. We built it. We got a land lease for 35 years. We built those buildings on it. We were told that if we want money, we're going to have to start killing our patients. And we said, well, we're not killing our patients. We're palliative care. We don't do that.

Right. The whole point is to just ease the suffering as they go through this experience.

Live well.

Life.

Yeah. Until your natural end, which we can help you with. Yeah, right. And so they said, well, you're not getting any more money. And we said, that's fine. We don't want your money and we don't need your money.

Wow. Okay.

Right. So we had we're sitting on this land with our buildings. So we had 25 years left on that land lease. So as soon as we started to resist and be defiant, not get into lock step, they canceled that lease with 25 years left.

Wow.

Right. They evicted us from our buildings, took our money away and basically took our facility from us, kicked us off the land and expropriated those buildings. \$8.5 million worth. And to the government. So the government walked in, started to operate our hospice with us gone and provide euthanasia there.

That is absolutely outrageous. And it does fit into this model. We're seeing where they will shut down a bank account. They go against the lease that's been signed. What good is a lease if it doesn't, protect the property for the and you've invested that funding and money into knowing you're going to be there for a period of time and all just because you're like, we're not going to offer death as one of the options in our hospice.

That's right. So you are now compelled, you see, and this kind of, um, MAID right is conquest and then compel. That's the dance. That's the modus operandi that they're using. Uh, and that's going to be facilitated by the court system, by the judiciary.

Right. And all of our our courts, our courts and our judges are appointed in Canada, appointed by the government.

Yes. And so the government is controlling the whole thing. And what's so what is the media come into this? **Why is the media not pushing back?** Because **I know here we have pharmaceutical control of our media, so we'd be kind of screwed here. But you don't have that in Canada.**

**No. We have government control of our media. The government gives the media billions of dollars.** So basically it's, you know, I joke kind of not really that it's like Soviet style Pravda. That's our media.

So none of the television stations, they all get government funding.

They all get money, but particularly the CBC. Yeah, that's the state media outlet. And they get money, right? And of course, you know, **we have never been able to get our message onto the legacy media, into the mainstream media.** It's all very pro made. **So people don't really even know how bad it is out there.**

Well, what if an institution, say, is like a Catholic institution or has a religious belief around it? It just doesn't believe in suicide. Do you not have a right to exercise a religious belief?

Well, we yes, in the moment, but again. Right. So they're compelling everybody to kill patients. And the only the last bastion that we have truly in Canada to protect authentic palliative care is through the faith based organizations. Catholic Healthcare, for example. Yeah, but now we see there's court cases against, uh, in British Columbia, against Catholic health Care to force them to provide euthanasia to their. So in a sense, it's going to destroy religious liberty in Canada. But you know, like everybody's equal. But, you know, some people are more equal than others. So now it becomes a constitutional argument that that's going to supersede, supersede, you know, the right for the state to kill its citizens will supersede religious liberty in Canada.

It's so crazy. I mean, the fervor around it. Just who cares? Alright. If you're if you're nuts enough to want to be, allowing people to kill their patients. Okay, you've gotten away with that. But why go out of your way when there's just a group that says, hey, leave us alone. We're just not going to do it over here? Like the fact that, like, no, everybody must be able to do this. Everybody must be able to kill. In fact, is there any mandate that forces that that offer, how do they make you offer it?

Well, because, you know, **they've stolen the moral high ground on this, right? And we're told that if you're a good citizen, then the only way that you can be compassionate is to kill people. They use words like dignity, dying with dignity. Well, actually, we were providing dignity. Right. To euthanize someone? By a bureaucrat, basically. Mercenary of the state. That is not dignity. Right. But no. So. Dignity. Autonomy. Oh, you want to have control? Really? The only one who's having any kind of control is the state.**

And in one of the videos in that montage, what's shocking is the one woman. She only needs care. She's just waiting so long to get that care that she said, screw it. I think I'm going to get a faster. I mean, I'll just go ahead and get MAID, go ahead and kill me, because that's going to happen faster than getting me the care that I need. And this is one of those things where we know people come to America because it's taking too long to get the surgery somewhere or taking too long. But this MAID they'll rush it right through your front door within minutes.

They'll come to you. They'll send a team to your house. When's the last time any of us ever got a doctor come to our house? No. We sit. We don't even have doctors. Many of us have no family, doctor. We on wait lists to get even the simplest of procedure. But they'll send a maid team to your house. So some people in, you know, depending on where they fall in the track, they can want maid and they can get it that day. There. That's track one. Fast track the maid. Kill the people.

Amazing. We've got a headline here. Take a look at this. "The number of assisted deaths jumped more than 30% in 2022. The report says." What percentage of of deaths in Canada are now euthanasia or,

Well, I mean, this is kind of a contentious topic because, you know, the government is releasing certain data. They're admitting to certain numbers. I don't believe those numbers, not for a minute.

Yeah. Here we go. Look at that. That rise. We're now up to 62,000 In 2023 assisted deaths?

No, I think they forgot a zero, actually.

Yes I do. Yes. And I've said that publicly many times.

Why is that? What is it? What does he think they're hiding?

Well, first of all, uh, the first reason is that they're not putting maid as the cause of death on the death certificate.

They're putting the reason why the person wanted maid or the underlying condition. Cancer. Cardiovascular. Diabetes. Blindness. Right. That's why, number one, that's happening across many provinces. And number two, the provincial governments are not transparent when it comes to releasing their maid data. In fact, they hide it. The only way we know and see those kind of numbers is because they give it to the federal government, and the federal government releases numbers. So it's there is a complete cover up as far as I'm concerned, because I speak about this across my country.

And every single talk that I give, I ask show of hands. How many people know somebody who's been MAIDED, or knows someone who has know someone who's been MAIDED? Every hand goes up. Every hand. At the most, we're two degrees of separation. There's a, you know, a population of 40 million. There's no way it's 60,000 people.

That's incredible. And it starts out. And I remember Jack Kevorkian. I grew up with that whole story. And frankly, in my family, it's kind of like, Alright. I guess if a person's really feeling awful, they shouldn't be forced, to be in pain. But watching you guys, I'm like, obviously there's a lot of things have changed my opinion since I was a kid. But now I'm like, oh my God, this is insanity. I mean, and and from the very mouths of the people that keep screaming at their visits. When you think of Trudeau at WEF, all talk about overpopulation, we got to do something about it. I mean, nothing better than a 24 hour team that will rush to your house as faster than you can deliver a pizza and kill you if you want. But what's shocking is it seems like it's. They want to act like it's for pain and suffering. We have an interview, um, that we're looking at of a girl. I mean, this doesn't seem like the right reason to kill yourself. Take a look at this.

26. Alright. For people listening, maid is a government supported, and in many ways, a government encouraged program of Assisted suicide in Canada, claiming the lives of thousands and thousands and thousands of Canadians. What got you here, sweetheart?

It was going to be super exciting. And, um, he found a reason to end things with me because I asked him in September if we could have a phone call, and he was telling me, you are the most nagging person. You're Quarrelsome, and he threw Proverbs 21:19 in my face. And then I was doing a lot to just get him back because he's been live on the air saying he finds it super hot when a woman is super obsessed. So I was telling him things like, oh, \$10,000 to be my boyfriend. I'll do anything because I wasted my whole summer.

I mean, she's on a list, right? She's, at least her practitioner is on the list. What are the rules of this? I mean, are there any parameters? Can someone that had a bad date or broke up or even going through a divorce and, we all have really bad. My son, who's 16, has been going through a really difficult, week or so. There's things at school and friends and all of it is kind of piling, going through one of those moments. I'm saying, I'm glad you're here in the house. I'm glad we're, going through this together because, life has its moments. It's going to have its moments where you're going to have to just grin and bear it and tough it out and recognize that on the other side of this is happiness and joy. But in Canada, it almost feels like, your school counselor might go, hey, you ever thought of just killing yourself? I mean, where does it stop?

Well, that's a very good question. Where does it stop? You know? Um, apparently there are eligibility requirements that we. But we have seen over and over again where those eligibility requirements have been violated and people have been MAIDED, and there is no there's no justice. Nobody goes after the doctors who are doing it. There there is no justice for the families. Um, it seems to me that the law around maid has no authority. Honestly. Um, the eligibility requirements are just ignored, and we see that truly, it is just coming after the vulnerable. If you're old, sick, disabled, mentally ill, homeless, poor. Like I said, it's a cull. They're getting you know, it's very much about eugenics. And they're they have the ability the maid assessors and providers. We have examples of having a five minute zoom meeting for a maid assessor, and they basically just rubber stamp the person who wants it. Anybody in my country who wants to be killed by the state can be killed by the state.

As it's amazing. And then as a part of, where's it going to stop? This is a recording of someone talking about where, how far they think this should go and should we be allowed to euthanize infants? We're taking I mean, here, of course, we have huge arguments around the idea of abortion. When is something to become a life. In Canada, it apparently doesn't matter if you already have a life at whatever level. I mean, they are just admitting, oh, no, outside the womb. Inside the womb. It doesn't matter if you think I'm crazy. Take a look at this.

Minors from 14 to 7 years of age. Nearly 18. Um, the committee recommends. And the board of directors supports as well that these minors could, with their tutors or parental parent, could make a request for maid based on the level of persistent and intolerable suffering that they may experience and become unmanageable and senseless. The same for babies from 0 to 1 years of age who are born with severe deformations, very grave and severe syndromes. Medical syndromes whose life expectancy and level of suffering are such that it would make sense to ensure that they do not suffer, given that their possibility of surviving is basically nil. And this is something that has been used in the Netherlands as an argument and we could explore that option. Finally, the committee addressed the issue of elders who are feeling. You know, tired of being alive. Sometimes what we in geriatric care call, you know, sliding into existential suffering or emptiness, whose are very fragile, whose physical abilities are, uh, so debilitated that the very fact that they're still alive becomes a real strain on them.

That seemed to just about almost cover the gamut. You have a handicapped child. Maybe you're, saying, I think they're suffering. You know, what? Quality of life. Let's just kill them. You have, you know, if you're depressed later on, you're what is it? What's this? Mature, minor, I guess if you're mature enough to know that suicide is an option, then you can get it. And elderly that are suffering from, loneliness, emptiness. I mean, so like, just like you're saying just about anybody and this idea of children. I mean, I just think of, one of the issues that we cover, one of the conversations right now, like autism, these, these beautiful individuals that some of them are doing really well and in college and at varying degrees of this spectrum, you know, there's there's a it's like if they've, they've planted we've done a lot of work on the fact that they're planting the idea that transgender is your issue. And so in the autism community, we're seeing a huge rise in wanting to get gender transition, because that will answer my problems. I can't even imagine if you went into this group and just said, hey, there's maids available to you. Are you having difficulty? Are you depressed? You feel like you know the world is out to get you or something. Have you thought of medically assisted? death? Yeah. I mean, I guess it answers all your problems in a country that just doesn't want to spend money on anybody. If you want to die. We'll let you die. Because, frankly, we could we could use that money back.

Well, and we know we're a country that has had public health care for a number of decades, and we're also a country that has had mass immigration thrown onto us in the last five years, maybe 5 or 6 million people have come into our country. So you can expect the, you know, the strain on the infrastructure. So our health care system is damaged. It is uh, it is broke, right. And so what, you know, so for me, it's a mix of ideology and economics. Right. So there's a panacea. Well, just kill them. Particularly the old people. Right? They aren't now have spent their whole lives working, funding this system, funding the medical system. Now they need it.

And now what? Easy. No pension. I'll have to pay them. I don't have any medical bills. I'll have to pay anything, right? My own mother, 91 years old, was offered maid.

Didn't come from her. She's my mother. She told them to get out of the room. But you know this. They're running around soliciting, recruiting for maid among the elderly population.

Like what numbers they'd like to get to if they're somewhere in the 5% committing suicide right now in the country of the deaths, is there a goal that they're mentioning, or is there is there just we're just putting this out there. And are there special clinics designed for this now? I mean, is it becoming,

Maid is offered everywhere, including they'll come to your own house. So we're looking at hospitals, long term care facilities, hospices, funeral homes. You can get made in a national park, right? They'll come to your home, to me, every place. There is no place

My last camping trip. And then. That's it.

There is no place that they won't. The concern is now there's no place where you can hide. My organization is looking to create sanctuary. Sanctuary for the dying. We're not allowed to. We could open up a sanctuary tomorrow. We have the money. We have the constituency that just wants health care and not MAID. And we are not allowed to.

It's amazing. So if they start allowing children, we have issues here where they keep trying to push laws in states that a child could vaccinate themselves without parental consent. In California, the states that you can go through gender issues, you can change your name without parental consent. All of these things. Do you see a future where this will be potentially offered in schools, where a child is having difficulty, maybe, issues with depression, that they could just say you're allowed to make this decision without parental consent?

Absolutely. Parental parental rights have been destroyed in Canada, and that came through the Trojan horse of the gender transition, the gender ideology, right? In Canada, parents have gone to jail when they have dared to speak out about the transitioning of their children. Yeah, right. You know, this this gender ideology taught to the children in the school and transitioned in the school socially. Parents find out, they say that's it. The child wants to go and have a testosterone or wants to transition medically. And the parents say no. Well, the 12 year old can go do it on their own because as a mature minor, they can make their own medical decisions. So once you destroy parental rights, then there is no one to protect the child. When the child decides, I'd like to get euthanized. I've had a bad day, a bad week. I don't like the I don't whatever or whatever. Yeah. So the law is not going to protect the children. The law? The parents can't protect their own children. And certainly the medical establishment is not going to protect our children.

Are they offering it in prisons also?

Absolutely.

Wow. I mean, it's just the whole thing is it is absolutely dystopian. I feel like Canada is sliding into a dystopian nightmare. For people watching right now, we're right on the border. I think there's a lot of people in America that are like, oh, that'll never happen here. Uh, what do you know? What is your what is your word of advice for America right now? It's your neighbor.

Yeah. You have to watch what's going on in Canada. Yeah, of course it can happen here. You know how we started, right? We started with these. Just the assisted suicide in the United States, I believe 11 jurisdictions allow assisted suicide. That's where the the doctor gives you some some prescription for some pills. You go home and you take.

So here in America,

So we're already moving this direction 11 jurisdictions okay.

Right. So in Canada we have uh, so California right about the same population as Canada, about the same kind of wokeness as Canada, except probably Canada is worse. Look, uh, 2023, Three, 800 people took assisted suicide in Canada in the same year, 15,000 according to the government numbers. Right. Because we don't. The vast majority of MAID is euthanasia in Canada. As soon as you cross that that line of euthanasia, it will explode. It will explode, I promise you. So the thing to do in the United States is to take our example, listen to us when we say what has happened. You know, with these examples, you have to stop the horse from leaving the barn if you want to stop what's happening in Canada, what's happened to happen here in the United States?

Sure. Yeah. We spent most of our time now trying to protect our people. We're a national organization, Delta Hospice Society.org.

Okay, there you are, folks. Delta Hospice Society. Org. All of you in Canada, obviously, they're watching this very important. But if you're in America, let's see if we can pitch in and help out before this thing turns into, uh, what's this right here?

That's our DNA defense kit.

Oh, it's your DNA defense kit. What? Tell me all about this. What is this DNA defense kit? This is something someone can download.

Yeah, absolutely. So what happened to us was, uh, in any sort of private people trying to help in the health care system, we all got pushed out to the margins. So the only the only people inside of the health care system in Canada now with government and unions, right. So on the periphery, the only thing that we can do is try to protect people inside the system. So we give them legal forms that basically say, don't talk to me about maid. I do not euthanize advanced directives. And we literally put a cart in people's hands that say, I require health care and not maid.

Wow, did they carry around in their wallet.

And it actually speaks for their lives. We have had example after example where particularly the elderly are sitting in the emergency wards and they have people approaching them, asking them if they'd like to be MAIDED right along with witnesses that they bring. All they have to do is sign here, sign here. Mr.. Be right. Mr.. B, which is an actual person, that the story will be released very soon who is basically attacked in emergency Ward, 92 years old, uh, twice. Uh, you know, trying to tell him to MAID himself. He pulled out our card and it spoke for his life.

And they just backed off. They don't want to tangle with the Delta Hospice Society. They might tangle with the 92 year old man with pneumonia, but they're not going to tangle with us. And so we say, get one of these into your hands. This will save your life.

I can't believe there's a country that calls itself free, where you have to carry a card to keep them from killing you. When you go to the hospital for any reason whatsoever. This is really, really shocking. The fact that they're looking at children now. There's no bounce to this level of insanity. It's obviously, control of society.
