Action! Good morning, good afternoon, good evening. Wherever you are out there in the world, it's time for us all to step out onto the high wire. I want to try a little bit of an experiment here. I want us to imagine if we could go back in time, take us to the height of the Covid pandemic. Imagine if President Donald Trump had marched out in front of cameras, the head of the CDC, the centers for Disease Control and Prevention, and said, I want you to listen to what the head of the most important health agency in the world has to say about our new vaccine, and this is what he said.

The problem is not the science of creating the vaccine. The problem was the public policy on how to use the vaccine. The vaccine should have never been mandated. It wasn't never meant to prevent transmission. It didn't prevent transmission. It probably was a misnomer to call it a vaccine. It's really more like a medicine. It doesn't stop infection. Children should have never been vaccinated. People shouldn't have been mandated to be vaccinated to go to school and work. So the policy side was totally misplayed. Okay. And I, I know I the vaccine came out on the 14th of December and I was out of office on January 20th. So unfortunately I had very little influence on the policy. But I did argue that it should be a vaccine that we should use for the vulnerable. Put it in the nursing homes, put it in an assisted living. Um, don't mandate this vaccine didn't belong in children. So a lot of overreach. And as a consequence, the mRNA was a new technology. It hadn't you know, we don't know all of the potential negative consequences. I'll say this briefly, because I see the timer when I give you an mRNA vaccine. And I've talked to the FDA and others about this. When I give you an mRNA vaccine, I don't know how much spike protein you make. I turn you into a spike protein factory. I think the FDA should know how much protein do you make? And I don't know how long you make it. I think we ought to know. How long do you make it? And I don't know the volume of distribution of it in your body. I think we should know all of those things.

I mean, seriously, just for a minute, would we have gone through the experience we went through? In all honesty, that is the leading scientist, head of the CDC, that is overseeing all the trials that are taking place at Pfizer and Moderna. And what he says is, look, this product is not going to stop transmission. Well, there's a newsflash that would have gone flown in the face of the 95% effective we heard on every single news agency there was. By the way, this should probably only be given to elderly people. It's really not even a vaccine. It's really kind of just, you know, an mRNA treatment. And we don't know anything about this technology. In fact, you know, it appears that it's going to turn your body into a spike protein manufacturing plant, and we don't know how long that's going to last, how much spike protein is going to create or how long it's going to create spike protein. And that's a problem. We really don't know what the health outcomes are going to be. Oh, by the way, you should never give this to children. Can you imagine? I mean took a little bit too long there. Doctor Redfield, to get around to giving us this information. But how different would the world we live in be if that was the official statement from the white House? Imagine if you'd have known that for all of our loved ones. If someone was just telling them, this product is like nothing we've ever seen, it's going to turn your body into, as he described it, a spike protein manufacturing plant.

What? Wait a minute. Actually, there was someone that was saying that I distinctly remember right before the vaccine came out. Right there. You know, at the end of 2020, someone was describing it exactly like that. Take a look. With an mRNA vaccine, which is messenger RNA manipulation of a message from your DNA to your cells to not only create antibodies, but to actually create the virus itself. So your cells are manufacturing the supposedly deadly spike protein inside of you, a coded message into the cells of our bodies, and telling those cells to produce the bioweapon. The toxic part of the virus known as the spike protein, turning our own cells into a virus manufacturing plant. This virus manufacturing plant, or more specifically, a spike protein manufacturing plant. Does anyone know how to shut it off? I mean, it's terrifying, these spike protein manufacturing robots, if you will, the rest of their lives manufacturing plants for spike protein. It's making our bodies essentially become a manufacturing plant for the most dangerous part of the virus. Is that correct? Yes, sir. I was actually just having coffee this morning with a, you know, top journalist out there who was saying, I mean, what would you admit? You've gotten wrong. And I honestly said, I'm not saying that, you know, we are infallible, but I honestly can't remember anything during the Covid pandemic that we got wrong here. Um, that's not because I'm some super genius. It's because I have an amazing team.

You rarely see running the show. You never see the international scientists that we meet with every single week. And you've never been through a meeting with attorneys like Aaron Siri that are drilling down and winning lawsuits against the government everywhere. They're trying to lie to us and finding through FOIA requests all the information that's been hidden. That is what's happening here at The HighWire every single week. And I said to this journalist, look, if you can find something that we got wrong, I'd be, you know, bring it to me, because all we've been doing is producing peer reviewed science. This is not a show that's put together on a crystal ball. This is not wishful thinking. This isn't a bunch of hippies sitting around eating granola, you know, hoping they're right about something. We've been delivering you the exact science that the head of the CDC knew before anyone in public was ever injected with this vaccine. He was exactly right. It should never be given to children. It did not stop transmission. But he sat there watching them lie about that and didn't really take to the TV to tell anyone they're wrong. They're lying to you. It's not 95% effective. It's not effective at anything. Maybe reducing your symptoms for up to 15 weeks, at which point it becomes negative efficacy. Now it's going to increase your risk of getting infected unless you want to be getting a vaccine every 15 weeks. So about four times a year, then this is one of the worst products that's ever been made.

And we really don't know the side effects of spike protein flowing through your body for God knows how long. You have to imagine that will not be the first pandemic. It's not going to be the first time we see. It's not going to be the first time we're lied to in the news. We have shown you time and time again they will lie every chance they get, and they will try to manipulate you and have you move through society in the way that they want you to. So where are you going to go? Where are you going to be when you want to say, I need someone with a track record that had it right all along? I hope you start telling your friends about The HighWire. I hope you start using little clips like this, which I'm sure will be viral this week saying wow, The HighWire had it right before anyone else was talking about it. New York Times still has it wrong. So does Washington Post and probably the Atlantic for that matter. Why are they getting it wrong? Why have they never been able to figure it out? Or why have they never admitted, hey, we got it wrong. We listened to the wrong people. I don't know. But now someone's finally getting it right. This week we're going to talk about several things that are happening in our government that are just this side of absolutely mind blowing. From the moment I started traveling this country with the documentary, VAXXED became very focused on this issue of autism in America and around the world.

I remember several, you know, would say to me, well, I just got to make this injury to my child means something. If I can't save other kids, then none of this will have had any value at all to anybody. Well, some of those people have just been added to a committee that has been there for decades overseeing autism. This is the headline. Secretary Kennedy appoints new interagency autism coordinating Committee to advance fight against autism. Let me read it again, because this agency, Interagency Autism Coordinating Committee, the I a C, is a committee that mostly is shilled for the pharmaceutical industry for decades. Having everybody spend money on things like the, you know, genetics that are causing autism as though genetics could cause a crisis that goes from one in 10,000 to 1 in 20 or 24, 1 in 30, wherever you want to look at the surveillance system at 384% increase just since 2000.

There is no genetic explanation for that. That is a toxic load. That is a poisoning. Something is happening. Sylvia Fogel, who was a great voice in our film and Inconvenient study, Daniel Rossignol, uh, let's bring back the names Elizabeth Mumper, John Rodriguez, Elena Monarch, Lauren Silini, Jennifer Phillips, John Gilmore, great great friend of mine, Kaden Larson, Kaden who, by the way, we didn't know that he could communicate. Maybe, I don't know, 5 or 6 years ago until he went through spelling to communicate a child that we didn't know where his education level was at until someone figured out a way for him to communicate. And now he's gone through college and he's going to be on a government agency speaking for autistic people in America and around the world. What a triumph this story is. Let's continue on with this list. Also, Elizabeth Bodkin or Bunker, who is also, um, an autistic person that learned to communicate through spelling many years ago. A miracle we've covered in the film the Spellers, um, or spellers we've had on. And you should check it out. Lisa. Uh, Toby Rogers, Walter Zahrahi, Bill Oldham, Honey Rinicella.

There is Robert Kennedy Jr in a cabinet meeting saying we are doing dozens to hundreds of studies looking at autism. We're going to get that done for you. Obviously, this is something that President Trump, Donald Trump cared about before he was ever elected to be president. The first time. There is huge change. These are literally the winds of change that are taking place around us. We should be critical of this government, but let's not lose sight of what is being accomplished. Um, my heart goes out to all those beautiful individuals that are now on this panel. And what is this panel going to do? This is how they describe it. The Interagency Autism Committee is a federal advisory committee that coordinates federal efforts and provides advice to the Secretary of Health and Human Services on issues related to autism spectrum disorder. Through its inclusion of both federal and public members, the IACC helps to ensure that a wide range of ideas and perspectives are represented and discussed in a public forum. The committee will reconvene in 2025 to begin a new session under the autism CARES act of 2024. They literally will be guiding billions of dollars. They'll provide advice and recommendations to the Secretary of Health and Human Services regarding federal activities related to autism spectrum disorder. Facilitate the exchange of information on and coordination of ASD activities among the member agencies and organizations.

Increase public understanding of the member agencies activities, programs, policies, and research by providing a public forum for discussions related to ASD research services and policy. Now something's finally going to be done about autism. Look out! We are about to get information, and we're going to get it from people that have been in it on the front lines most of their lives now. This is so important. It's so critical. It is such a huge step for mankind and a huge step for health. And the **Maha movement in America** got a big show coming up. I'm going to talk about a controversy up in Minnesota that you may not have heard about. But first, it's time for the Jaxen report. Amazing isn't Jefferey. You know, we've reported on spellers to see some of these brilliant individuals that were trapped inside of a body, unable to communicate, people assuming they maybe had a third, fourth grade, you know, education level, only to discover that there's these geniuses inside. This is this is, in my opinion, one of the biggest headlines of the year. So this is Godspeed to all of those people on that. **And this is this** current administration is concerned. One of the action items when it came to power was to get out of the W.H.O., the World Health Organization. While that action item has been achieved and finalized, this is a press release from HHS. United States completes WHO withdrawal and corresponding press release from the World Health Organization. They say this W.H.O. recommended the use of masks, vaccines and physical distancing. This was during the pandemic, but at no stage recommended mask mandates, vaccine mandates or lockdowns. One of the big reasons we are withdrawn from the W.H.O. is because of their handling of the Covid 19 pandemic and how they really shaped, shaped the way countries responded. Well, they're saying there that we never talked about lockdowns. We never we don't know what you're talking about. Well, a quick search on X at the time Twitter showed this.

This is the W.H.O. own account. It says this is on May 2020. "The human cost of Covid 19 has been devastating and the so-called lockdown measures have turned lives upside down. But the pandemic has given us a glimpse of what our world could look like if we took the bold steps that are needed to curb climate change." So they're saying, yeah, the lockdowns, those were tough, but we could do those for climate change. It goes it goes on. It's there's another this is another message. Same year 2020. As we have said, so many, as we have said many times, so-called lockdown measures can help reduce Covid 19 transmission, but they cannot completely stop it. Contact tracing is essential for finding and isolating cases and identifying quarantine their contacts. So they're saying, look, lockdowns are great, but we also need contact tracing. We also need to find these contacts, maybe some vaccine passports here or there. But remember China was the first country to lock down and then all the other countries really followed. China's efforts to contain the outbreak at the epicenter have been essential for preventing the further spread of the virus. The level of commitment from China is incredible. Some people on social media will be open with. You were criticizing for praising China. I will praise China again and again because its actions actually helped in reducing the spread of coronavirus to other countries. The commitment of the political leadership, starting from the number one from the president himself.

What China has demonstrated is you have to do this. And if you do it, you can save lives and prevent thousands of cases of what is a very difficult disease.

The next pandemic is not a question of if, but of when. And we cannot afford to repeat the same mistake of the past. That's why member states are negotiating a new pandemic accord and amendments to the International Health Regulations to strengthen the legal framework for the global response to pandemics. And we can't stop there.

It's, you know, as you said, you know, good on China. Remember the images of the giant apartment buildings, people crying out, locked in their apartments, people trying to leave and being tackled by police if they didn't get the things rammed up their nose. And that's what they said. We will praise that again and again and again. And when they had that pandemic treaty, which I went to Switzerland to protest against, I've never been happier about the United States of America and our leadership than bagging out of the W.H.O., which is a globalist attempt to destroy the sovereignty of America, to destroy and override our freedoms. So good riddance to that horror show that used to be called a health agency. Nothing. This is really great news.

And in replace of the United States, California is taking the role. So you have here as the US bids adieu to the World Health Organization, California says hello. So on the weekly calls to the W.H.O. that federal officials are usually on, they're not on there anymore because we're out of it. California has stepped in. Remember, California is part of the West Coast Alliance is leading it. And we also have an East Coast alliance who essentially stopped doing any type of new science since the moment the vaccine was released. So we're talking five years. They've had a blind eye to any new science from the vaccine, from health policy. And there has been a big push, particularly by RFK Jr. To reduce the number of vaccines that are mandated, if any, for school kids who are entering primary education in the United States. How much is that affecting your business?

So it is sad for us to see that vaccines that have been proven through decades, helping people around the world are not recommended anymore. Um, and that's really for the medical community and the doctors to discuss with their patients about that. What is important is really, of course, to focus on people at a high risk. Uh, but some of those vaccines, if you think about it, the HPV vaccines has proven to prevent cancer. I mean, think about this. A vaccine that you get in your youth has shown across, you know, so many people across so many countries to prevent cancer. How many vaccines would you be willing to take to prevent different types of cancers? I would be willing to take a lot.

Did you feel like, though that is going to affect your business and your ability to develop more vaccines, you know, develop to invest because it does reduce demand for these, uh, inoculations?

**[00:22:13] Stephane Bancel, CEO of Moderna Therapeutics**

Oh, 100%. And we've said very publicly to our investors that we do not foresee investing in new phase three study in the foreseeable futures in vaccines because you cannot make a return on investment if you don't have access to the US market, or because of delays regulatory wise, or because your market is much smaller, because you don't have a record by the government. And so we are investing in cancer. We're investing in rare disease, but there's a lot of vaccine that I think could have a huge impact on public health that were unfortunately not being able to take two phase three.

There is so much that, I mean, I'm just boiling up. We only have a couple hours here, so I'm going to contain it to this point. First of all, Gardasil HPV vaccine is not one of the ones that were removed from the recommended list by the CDC. So he's got that wrong. It never has proven to stop cancer. We've gone deep into that. It only showed precursors which also disappear on their own. But whatever, that's just a mere formality. But this idea that they're going to stop phase three trials because we just can't get a return on investment when we have an HHS that is demanding safety trials using placebos. We can't get a return on investment. We have Doctor Marty Makary at the FDA saying we're not going to approve a vaccine does not prove to be able to stop the circulating strain of whatever virus you are fighting. So all of a sudden, simply because we need quality in this product, the same companies that make drugs, we've been saying this all along. Jefferey if you just had them go through the same gantlet of safety and efficacy that every drug we take, these wouldn't be on the market, and they just proved our point. They won't be on the market because they can't go through simple safety trials. We're just asking for placebo trials. And he's saying to his investors, if you do that, there's just no way for us to make money. And if you don't force it on the American population and just mandate billions of these to be sold, that it's just not worth, we're going to make more money on some rare cancer vaccines and things like that. Okay, Stefan. Thank you. I think we're going to head and read through the lines on what you just told us there. It's exactly what we thought.

Absolutely. And he starts out by saying he's sad that the mandates aren't happening. He's sad that now it's a doctor patient relationship that they can decide about our products. That's a sad thing for him, clearly.

Now let's move over to actual vaccine testing and let's move over to Guinea Bissau. And this is out of the New York Times. This headline Kennedy planned to test a vaccine in West African babies is blocked. What's going on there? Well, it says the West African nation of Guinea-Bissau has suspended a controversial US funded study of the hepatitis B vaccine in infants there, after an outcry from public health researchers over the ethics of the work. Well, what's Kennedy doing that's unethical? International agreements on medical research and humans requires researchers to offer the globally accepted standard of care, in this case, vaccination, at birth, to any participant in the clinical trial. But in this study, half of the 14,000 infants studied were not going to be given the vaccine Until they were six weeks old. So they're trying to do some some research here because remember vaccines.

Take this back. I just want to point out and just just so people really burn it in, this is a totally incorrect statement. This is not the world known standard of care. In fact, we just took on the Danish study. They don't give a day one hepatitis B vaccine. Germany doesn't. Many nations don't. In fact, we're one of the only ones that were giving it on day one of life. So let's be clear. All Kennedy is doing is saying we're going to allow half the kids of Guinea-Bissau, Africa to now go by the current American schedule, the one used in the Danish schedule, in the German schedule. So they're lying to you. This is not the world accepted day one. We're on the world accepted now. And suddenly they want to make us think about this. But you have a bigger point to make. I just want to point that out.

Yeah. And this was, as we saw at ACIP, this is a hepatitis vaccine who was grandfathered in. The safety studies were following kids for just a matter of days after they after they injected to see if this vaccine was safe. And also this this is a vaccine that we know that it never was meant to be given to every child. You can screen the mother and it's been pushed onto the US population. So let's talk about the the ethics of Guinea-Bissau, of the officials there. Well, beginning in about 2017 and moving through the years, I can put legal letters forward to Unicef. Unicef is the main vaccine distributor in a lot of these African countries. And what's it for? Well, we found out about a study of DTaP, the DTaP vaccine, and it was killing children at a rate of about 5 to 10 times more than it was killing children.

Let me just Jefferey just so we get it right. DTP not DTaP. Dtap is what we use in America. DTP is the old version. I just want to make that. Go ahead.

Yes. Thank you, thank you. So DTP so Unicef actually didn't really answer it didn't answer that call. So we took it to the criminal court the International Criminal Court, for crimes against humanity because they were giving this vaccine. What am I really talking about? Let's talk to Christina. Ben. She was doing a Ted talk. She was one of the lead researchers on this study to show you what was going on there. Take a listen.

**[00:27:27] Christine Stabell Benn, Professor in Global Health at the University of Southern Denmark**

Okay. I'm a medical doctor and a researcher. And for the past 25 years, I've been working in the small West African country, Guinea-Bissau. We started doing what nobody else had done before us. We evaluated the effect of vaccines on overall health before we started looking closer at DTP vaccine. It had only been studied for its protective effects. In one study, we went back to historical data from when DTP vaccine was introduced in Guinea-Bissau in the 1980s, and the results were scary. In spite of being protected against three deadly diseases, the introduction of DTP was associated with increased overall mortality. Children who received DTP vaccine had five times higher risk of dying than those who didn't. And this is just one example of many studies now done of DTP vaccine. And they all show the same. The protection against the three deadly diseases comes at a very high price, namely increased risk of dying. So with the best of intentions, the use of DTP vaccine may kill more children than it saves. Based on these observations that if we modify the existing vaccination schedule in low income countries, then we could save 1.1 million children every year, 1.1 million children. That's equivalent to more than 3000 children every day, with minor modifications of the vaccination program. I know these results are extremely uncomfortable and most people, including myself, just wish they weren't true. But this is what the data tells us.

So the same ethical group that doesn't want to allow a study using the American Denmark German schedule on the children. There is the same ethical group that is continuing to use a vaccine, even against our lawsuits in the International Criminal Court, that if they reduce those vaccines, they would save 1.1 million children per year. I didn't say that that is coming from the mouth of the person, one of them that was responsible for the DTP vaccine program. You want to talk about an about face? This is someone that wanted to see this. No one wants to admit they're wrong. No one goes out of their way to prove that my life's work has been an accident. I mean, and she's not alone. You got doctor Peter. Abe has said the exact same thing. The senior scientist involved in that program. Yet no changes from these very same people. Yeah. Let's talk about ethics.

Exactly, exactly. And so let's talk about continued, uh, lower income countries and their vaccination programs because we have something coming out with the polio conversation. Remember, in 2019, the Associated Press put out this headline, More polio cases now caused by vaccine than by wild virus. Why is that? It says in this article, "in rare cases, the live virus in oral polio vaccines can mutate into a form capable of sparking new outbreaks. All the current vaccine derived polio cases have been sparked by type two virus contained in the vaccine." Now for the entire polio story, we have a documentary. I did one Jefferey Jaxen investigates. We played part one on Christmas Day. Part two is available at Highwire plus. This is an hour long deep dive documentary on polio from start to finish. And this is the newest information in this conversation. Health officials have been looking for polio vaccine that doesn't revert back to wild type and continue this polio outbreak because it makes eradication impossible. Well, I think they may have found one. This is nature. This is the huge medical study that was just put in "higher stability of novel live attenuated oral polio virus type two." It says the new novel oral poliovirus type two was developed to reduce the risk of circulating vaccine derived poliovirus outbreaks by incorporating genetic modifications to enhance genetic stability and reduce reversion to virulence while retaining protection, so apparently they found it. However, they write a double recombinant strain identified in a sewage sample lost all key nopolv2 modifications through recombination with enterovirus C strains upstream and downstream of the capsid coding region. This resulted in high neurovirulence comparable to that of wild type two poliovirus, so it didn't work. Not only did it not work, you have a genetically modified strain of this thing now floating around in the sewage, able to have high neurovirulence, just like the old ones that were reverting back and continuing this polio epidemic in these lower income countries. So that's the new science, I guess.

Back to the drawing board. Well, I want to move over to China here because currently we have UK Prime Minister Keir Starmer. He's visiting with the leadership in China right now as we speak. And you can see some of the images there. He went over to make a visit. And it's very appropriate because over the last couple of years under Keir Starmer's leadership, the UK has made headlines like this. "How Britain became a surveillance state." Here's another one under "UK under spy in the Sky surveillance has hundreds of drones deployed across the nation." And here's the latest "minority report policing to catch criminals before they strike." It says in this article "the government is investing in 4 million pounds in creating an interactive, AI driven map of England and Wales by 2030 that aims to stop criminals before they strike. The project will use official data to identify areas that are likely to see criminal activity, such as knife offenses or spot early warnings of ready for this anti-social behavior, whatever that means, so that police can intervene before it escalates. They spoke to British Home Secretary Shabana Mahmood in this article and she said this."

"When I was in justice, my ultimate vision for that part of the criminal justice system was to achieve by means of AI and technology what Jeremy Bentham tried to do with his panopticon. That is that the eyes of the state can be on you at all times." This is a chilling statement. Jeremy Bentham was a British philosopher. Yeah, we have Jeremy Bentham. He's a British philosopher, late 18th century. He innovates this idea. He comes up with the idea of prison design, and it's basically where a single guard in a central tower can observe all the inmates in the surrounding rings of the cells. It creates a feeling of constant surveillance. Um, it acts as an all seeing eye. Bentham also envisioned this to apply for other institutions like schools, factories, and hospitals. To give you an idea where his mindset was. But what this does is this constant surveillance encourages basically self self-discipline. It encourages fear in people because they never know when they're being watched, so they try to self check themselves.

Assumption is you're always being watched at any point you're being watched. Therefore, I must always consider myself being watched.

Right. And so this is what the UK police this is their gold standard. This is what they want to achieve. All seeing eye policing. And so their new white paper just came out in talking about a new model for policing. And it says this we'll be investing in facial recognition capabilities and the responsible adoption of these okay. This will include over 26 million pounds of development and delivery of a national facial recognition system and 11.6 million pounds on live facial recognition capabilities in national coordination of these, just like China. And here's the cool part 40 new live facial recognition vans they'll be driving around will be available to support the police and town centers and high crime hotspots across the country. So that's the UK. Um, they're they're rapidly devolving clearly into into a surveillance state here. And we're talking when we talk about AI. Clearly this is going into the policing we're talking about. AI is taking a lot of our jobs. And it's only moving faster at this point. It's being installed in government to what ends. We'll see pretty soon, I think. But this rapidly moving throughout society and people are left to wonder what what is left for the human experience. And when I look at this headline here and this this caption, this image from Canadian Canada's maid, that's the medically assisted suicide the government has put forward. And they have a statistic here about people that that go through this pathway to end their lives from government sponsorship. And it says the reasons they do it. 86.3% do it because they cannot engage in meaningful activities. Meaningful life, meaningful activities is a key to the human experience. And AI is is probably going to take some of that away. In fact, don't listen to me. Here's Elon Musk just last week at Davos. Listen to what he had to say.

Actually my prediction is in the benign scenario of the future that we will the robots will actually make so many robots in AI that they will actually saturate all human needs. Meaning you won't be able to even think of something to ask the robot for at a certain point, like there will be such an abundance of goods and services because the my prediction is that there'll be there'll be more robots than people.

So but how do you then have human purpose in that scenario?

Yeah. I mean, you know, there's nothing's perfect, you know, but.

And in all of his discussions and all of his building of robots, he hasn't figured out an answer to that question. Well, nothing's perfect like robbing us of the human experience completely. Um, it just it's sort of like what we see in pharma, right? It's like a polio. Let's just go ahead and start giving this thing to everybody and let's see what happens. Sure, there could be some side effects out there, like, you know, people just wanting to kill themselves, but we'll cross that bridge when we come to it. Um, it's it's it's really why the world is as difficult a place as it is right now. Is too many people not thinking things through or in charge.

And one of the key parts of the human experience is informed consent, parental rights, the right to basically dictate your own sovereignty and not have a government tell you what to do. And I want to talk about all of the bills now that are being put forward in the US. Now, this is the age of Kennedy. This is the age of a new health paradigm in the United States. And states are reflecting that by the bills that they're putting forward some good, some bad. This is a battle that's happening right now under our noses in almost every state. Uh, one of the states, new Jersey, put forward a bill that this is the headline here. "Did new Jersey just take control of your children's health?" This is vaccine bill A616. What this does is it aligns new Jersey and allows their Department of Health to make vaccine decisions and mandates and recommendations away from ACIP so they can rely on American Academy of Pediatrics or several other trade groups that take money from pharmaceutical companies to make these to make these recommendations. And they're part of this East Coast alliance, just like the West Coast Alliance. So you see a lot of states doing these similar things to just basically take a sip out of the picture and make their own rules going forward.

Um, we have Michigan, Michigan put forward 11 bills Michigan Democrats roll out vaccine bill package as GOP raises concerns. So this package 11 different bills wide range of different policies from mandating reporting immunization to modifying exemption forms. So, um, eyes on those heads up, Michigan, because those are coming in hot. A lot going on there. All of those 11 bills are things that, you know, we're we're really keeping an eye on because there's something that we would like to see. You know, we wouldn't like to see too much of this going forward. So Massachusetts, we have two bills here that are kind of carried over. And these are bills to really get rid of the religious exemption, but also to put forward reporting, school reporting and make that public. We know that that is an issue for the communities. It shames parents. It puts pressure on these children and their families within communities. When you make these, make these numbers public. So Massachusetts is going in that direction. But then we go to Iowa.

Absolutely, absolutely. And so we have some, some other bills moving in the opposite direction we had out of Iowa. This may make Stephane Bancel somewhat angry, but out of Iowa we have a HPV vaccine bill. S 304 House subcommittee approves bill requiring parental consent for HPV vaccine. So with sexually transmitted diseases, minor children can make decisions without parental consent, often without their knowledge. This this actually has the parents come in and be part of that decision. And to understand that decision for these minor children. So why is that a big deal? Well, parental rights is one of the leading nonprofits basically showing what kind of parental rights are throughout America. And we have an issue with parental rights, not just in the vaccine space, but there's a lot of other spaces that this drips over into. And here's a here's an image from their website. What percent of states have state statutes that define and protect parental rights? 60% of states have no statute. Only 40% of the states have statutes that define and protect parental rights. So anytime we're seeing an increase in, that seems like a pretty good idea. Now Hawaii this week two bills came forward. Remember, Hawaii has tried twice now over the last 7 to 8 years to try to take away the religious exemption to vaccination. So now we have two bills pushing back. We have HB 2166. And in this bill it says this no child shall be subjected to medical examination, vaccination, revaccination or immunization of a parent or legal guardian objects based on a bona fide religious tenets and practices. So now they're pushing back with this religious exemption and religious rights essentially in that state. We have another one out of Hawaii as well, HB 2199. And these are rights to bodily autonomy. So any citizen there can refuse any health or medical intervention, testing, treatment, vaccines.

And this is again based on religious or conscientious personal beliefs. So they're going hard in Hawaii, which is which is good to see. Florida also a lot of going on right there. It's a huge hotbed. We had a lot of Po. We had DeSantis come forward and said no more mandates. This bill, vaccine manufacturers could get hurled into court under bill moving through Senate. This is SB 408. So any vaccine that's advertised in the state, if that harms somebody that's taken it. They have three years to sue the manufacturer in that state. So this is kind of like a like a vaccine court within that state. So this is really, really interesting to see here how that's going to play out. And then the big bill is the medical freedom bill SB 1756 out of Florida. Is this the headline requires safety and risk information before kids receive vaccines. So not the home run that many were expecting. We we were expecting zero mandates. No more mandates for any vaccine. What this does is it allows the injecting doctor or physician has to give the parents all the information they have to get a signature from the parents before they inject the child. One of the things that was slipped into this bill, however, is a quarantine, a quarantine amendment. It allows the state health officer to quarantine anybody if there's a health emergency that has not been vaccinated. So that's one of the things that a lot of people on the ground are fighting to get out of there. This thing is moving hot and heavy through through the legislature right now. So keep an eye on this because we don't know where it's going to end up.

I think a lot of us were like, good, jeez. I mean, our taxpayer money going to criminals, billions. I mean, when they're starting to talk about the numbers across Minnesota, billions, tens of billions, maybe hundreds of billions. Look at this epicenter of fraud. Minnesota's empty stomachs. Fake autism therapy and scandal that could stop could top \$2 billion. Wouldn't you love to have that money back in your pocket so you could spend it in the right place? But you know, who would that hurt? You know, they shut it down. Good. Shut it down. Well, what about all of those daycares and autism centers that were doing it right that have real children inside of there. It's affecting them, too. And that has been brought to our attention by Jennifer Larson, who runs one of the biggest autism facilities up in Minnesota. This is her testifying on that issue.

My name is Jennifer Larson. I'm the founder and CEO of Holland Center in Minnesota. I've been an autism provider for over 20 years and started the organization for my son. What started as a small program grew over two decades into four locations that families rely on, not just for therapy, but for hope, routine, and survival. And this week, Holland and other programs all over Minnesota are collapsing. Not because we committed fraud, but because a crime ring was allowed to operate inside Minnesota's service system. And the government's clumsy response is now destroying legitimate, long standing providers and devastating families that we serve. When services disappear, families do not just simply adjust. They face a crisis. For more than two decades, Holland has served hundreds of children year after year, employed hundreds of clinicians and staff, operated under yearly on site audits, inspections and documentation. Oversight, delivered real services to real children every day. We have always complied with everything the system required. Yet within the last month, the state has withheld over \$400,000 in Medicaid funds for my own program, and that number grows every single day. What happened in Minnesota had nothing to do with the ethical long standing autism providers.

What did happen was organized criminal networks that exploited autism services by opening fake centers, billing for children that did not exist, billing for services never delivered, and stealing millions of taxpayer dollars in the process. These are not minor compliance issues. They are criminal enterprises. Families trusted that the government was protecting the integrity of the system. It failed. Now, instead of doing the obvious thing and targeting criminal actors, the response has been to freeze everyone's payments. That decision does not punish the criminals. It punishes innocent children and families. Autism therapy cannot be paused without consequences. Loss of services can erase years of progress in weeks, and abrupt disruption of services can cause lifelong consequences in these children. This is not abstract harm. It is daily trauma for families already carrying an extraordinary burden. I built Holland for 20 years. Families built their lives. Around the care that we provide. All of that is risk of destruction today. Not by fraud, but by clumsy government response that failed to distinguish between criminals and caregivers. But families and children should never pay the price for government failure. Thank you.

Well, there's repercussions to everything that happens in government. And this is one of those stories. It's my honor and pleasure to be joined now by one of the most powerful autism moms I've ever met, Jennifer Larson. Hi, Jennifer. Hi. It's great to have you on. I wish it was under better circumstances. This is a really, really terrible story. Um, so I guess my first question would be, as this fraud story started breaking loose all over Minnesota, people taking advantage, making up autism centers or a center of it that had nobody in it and things like that. Did you foresee as that was happening? Uh oh, this could cause a problem. Did you did you imagine you could get pulled into this?

You know, at first when a lot of the centers started popping up, um, I thought, great, because I did the same thing for my son. I started a center because I wanted a program that was right for him and there wasn't enough programs, and we've had a waiting list for five years. So I was very supportive when I started to see some of these centers pop up out of the blue. And in fact, some of them reached out to me for support and advice and to consult. And that was years ago. But then as it continued and where we went from, you know, a few of them to 300 to 400 centers, it seemed there was a red flag there. Um, there is a high prevalence of autism in the Somali community. And so it didn't raise a red flag right away. But after and it's not just Somalis, but after 300 to 400 centers, it didn't make a lot of sense. Um, what was going on in our state?

And so as this, you know, just a couple of weeks ago, as this really started breaking loose, you then must have been caught by surprise that there was that level of fraud taking place in and around you in the state of Minnesota.

Everybody in Minnesota heard about the daycare fraud probably ten years ago. Um, and then it just kind of went away on the news and I, you know, good for Nick, Shirley. But, you know, I don't have the time or energy to go investigate every autism center, so I'm not going. I'm not a, you know, citizen journalist, but I don't I don't think most Minnesotans are surprised by the fraud. I think they're surprised by the level and magnitude of the fraud because, um, living here, it's kind of become one of those unfortunate issues in Minnesota that just exists in where we live.

Yeah I get what you're saying. And we have to be careful. There's you know accusations of racial issues around this that get tagged on this which aren't right. And I do want to point out because you mentioned it early on in my investigation as I was traveling with VAXXED, one of the anomalies that really stood out was this massive autism spike in the Somali community up in Minnesota. I've said the CDC should have built one of the biggest centers in the world inside of Minnesota since that Somali, you know, group had the highest rates recorded at that moment anywhere in the world. It didn't make sense. They were my understanding is they were bringing in, you know, witch doctors to try and do seances on their children because they had never seen it. They didn't have a word for autism. So that's a story that you and I have discussed prior to all of this. That's also at the center of this discussion. But unfortunately, that problem was taken advantage of and then turned into this giant money laundering theft in Minnesota.

Yes. And it's it's nothing to do with their community. I think, you know that many of our advocates, Andy Wakefield, Mark Blaxill, myself, Patty, Carol have tried our hardest to help that community as much as we can and serve that community. So it has nothing to do with that. It's just that they started to pop up. I didn't think it was the problem that it was becoming because of the high prevalence, is all I'm trying to say.

It gave cover, right? It was like, this is happening for a reason. It should. Look, we need that many centers. This is the thing. And when we really talk about it, people have no idea how many autism centers we need in this country. We have no idea how big an issue this is, because if it's not right inside of our household, we don't know what it's like to take care of these kids. And that's the work that you're doing. So how many facilities do you have and how many children and people are you treating or, you know, working with that have autism?

**[00:59:53] Jennifer Larson, Founder and CEO, Holland Autism Center**

I have four locations and we have about 200 kids, and some of them come, you know, as their school replacement. Basically, that's what my son did for many years. And then others are kind of inpatient or outpatient, kind of going in and out for speech out or whatever they need behavior services or consulting. Um, so yeah, about 200 I serve right now. And then I have about 115 employees.

**[01:00:17] Del Bigtree**

Wow. I mean, so it's it's a I mean, to me, that's a big operation, certainly bigger than the work that we do here with ICAN. You've been dedicated to it. One of the as I've said before, one of the most dedicated people in this movement on this issue. Um, so when this happened, when they suddenly just froze funds, did they essentially just blanket? I mean, it was I guess when I saw the headline, I was like, they can't really just be freezing everything. That's just probably a headline. But they literally the Trump administration, it was a federal decision to just freeze or HHS freezes all child payments to Minnesota after viral fraud allegations. Did you get a call? Did you get a warning? How did you find out?

**[01:00:59] Jennifer Larson, Founder and CEO, Holland Autism Center**

So here's the confusion. I think that was for the daycares, okay, that the Trump administration did that. What happened to us was actually a Walz decision. Oh, really? 14. Yes. 14 categories. Of Medicaid funding, 13 of which are disabled children and adults. It's transportation, it's adult housing. It's all 13 of the 14, like I said, are disabled. He picked 14 categories and said, stop. We're going to put these through prepayment review. It's called it Optum's AI and Optum, an insurance company who, you know, their job is to deny claims, suddenly got all our claims. And I mean until today and I did get some money today. The last date of service that I got paid on was December 5th. They withheld all the claims for everybody, regardless of who they were, that I've been in business over 20 years, that I've had audits every year on site. I've been like and all the other providers like me, I mean, I know, I know a lot of really great providers in the trade group I'm in and everybody got all their claims got held for no reason at all. No, there was no I'm sure there's no issue. But they just held everybody because they didn't know what they were doing. And then that went two cycles and we started to raise alarms, obviously, because my payroll is 250,000 every two weeks. Wow. And this is a yeah. And it's a company that's thin margins. I've never paid myself in 20 years. It's not we're not like rolling in dough to be able to like bank.

**[01:02:24] Del Bigtree**

That just gives you a sense of the cost of autism, which is something I've talked about before. People have no idea. That's for for 200 kids, 150 outpatient. It's 350, all in \$250,000 every two weeks.

**[01:02:39] Jennifer Larson, Founder and CEO, Holland Autism Center**

Yeah. And so my Medicaid payment basically covers my payroll. And then the rest of it has to cover my rent and anything else that I have to pay for. Right. You have all your business expenses. So when they cut off, when they cut us off, uh, you know, we can't make our payroll. And a lot of the companies here have already gone under. They've just had to shut down. I last week finally said, look, who wants to go on unpaid leave because we can't afford this. Um, we finally did get paid some this week for the first two cycles, but now they're two weeks behind, so I'm going to always be \$300,000 in debt because they're just withholding payments.

**[01:03:18] Del Bigtree**

Well, and let's be honest, we've been working on this story with you for the last few days. You literally said on your show on Thursday, if this payment doesn't come through, I'm going to have to shut the doors on this facility. So we're lucky that the story is not as gruesome as we were planning on. Thank God. I want to, you know, say that thank God some of that funding came through this very morning. But I want to just talk about for people that don't know what that would be like. I mean, I think we just had a freeze here in Austin, Texas, and our kids weren't in school for five days, you know, is that, you know, when you shut down a school, even if it's for short periods of time with children that are autistic or on the spectrum, what does that do for that type of person?

**[01:04:05] Jennifer Larson, Founder and CEO, Holland Autism Center**

Like I said, it's a complete crisis. And, you know, I've had parents calling me crying. What can we do? How can we help? And, you know, they're doing the best. There's not a lot they can do because it's just such a big gap of money, you know? And they're scared to death. I have some parents. I have a parent whose child has been discharged from five other locations, um, and now is spelling at my location and doing wonderfully. And they're scared to death. And these, these kids, they don't. They need the stability, their, you know, their whole day, um, you know, they get their behaviors, their aggression, and everything goes off the rails when they don't have their routines. I know that I'm a mom, you know? I mean, I know my son, and he's pretty chill sometimes. But, you know, when these kids, they have their routine and they know what they need and they need to have that stability.

**[01:04:54] Del Bigtree**

I mean, that routine is part of what you work on, right, is getting them into a routine. If that routine breaks in some instances, you know, I was just talking to some folks that work here, um, uh, with us that, you know, have children at home that are dealing with this. They're like, once you break the routine, sometimes you have to start all over again. A year's work or more, you're back to ground zero, trying to build back the trust and all of those issues. So, you know, let me ask a harder question, because as we sit here watching all this fraud taking place, how easy is it to commit fraud in Minnesota? Is it just like nobody's paying attention to the amount of money you're bringing in? Because I know that you're on the up and up, as you said, you're you know, I've seen your facility. It's incredible the work that you do. But obviously you have an insight none of us have. Is there just a lackadaisical government there that just throws money at you and never asks a question?

**[01:05:56] Jennifer Larson, Founder and CEO, Holland Autism Center**

I've talked to my billing people about this because with all this prepayment review, I really wanted to understand in depth each of our claims because they were being held. And my billing people will say, there's no way this didn't happen without, you know, help. Because if we bill maybe 15 minutes on accident for a child, over the allotted time we get flagged, which rarely happens. But sometimes, you know, you make a little error how they were billing for kids that didn't exist, how they were billing 24 hours a day with one therapist with eight kids, how they didn't have on site audits like we had every single year. Somebody comes in, sits down and says, I want to see these files of these kids for this time on this day. And then they want to see the kids. And if they're not there, you know, well, this kid's sick and you need to say, where is the kid? So the amount of scrutiny we go through on a daily basis for 20 plus years to make sure that every single thing we have to build, when we build, we have to document every 15 minutes. And so, I don't know, I mean, it's astounding. It's, to say the least, that this was allowed to happen. Um, with 3 to 400 centers that weren't serving children with disabilities. And what could you think about a more awful thing to be doing than pretending to serve disabled children?

**[01:07:17] Del Bigtree**

I can't, and I, you know, I know you're being careful, but what it sounds like to me is if you are having to have scrutiny over every 15 minutes that's happening with a child, they know if the child has been sick or missed a day and they're all over you. How, as you put it, is billions of dollars flowing into centers that have no kids in it. And some kid with a video camera can prove that that looks like government corruption, that looks suspect. And I hope an investigation gets into any government officials that are involved in that in your state, in every state in this country. It is time to clean this stuff up. I mean, you know, we're all it's hard for a lot of people out there, especially parents that are, you know, footing the bill. You know, even the Medicare Medicaid doesn't cover all of the things it takes, as you know, to raise a child with autism. I mean, it's an astronomical expense, let alone just what it takes to be at home, to not be able to get to your job at times. All of the way that it affects you. And to think that you're paying taxes that are just going to fraud like this, it's it's really disturbing. Um, so is there light then today, as you're seeing these payments, you're going to be behind, you know, something? I can't imagine \$300,000 every two weeks. It's a lot of money. But is there communication opening up? Do you feel like they're going to get this fixed?

**[01:08:43] Jennifer Larson, Founder and CEO, Holland Autism Center**

I think DHS, uh, there was a hearing yesterday, and they're trying to say that they're up to date on their billings, which they're not, because we're all two weeks behind. I think they it was a knee jerk reaction. They didn't actually think about the collateral damage. They damage. They didn't think about the fact that we can't bankroll 90 days of payroll. We are, you know that this isn't this isn't a well, who can. I don't know what industry can bankroll 90 days of payroll, but, you know, I think they are actually seeing the light and regretting what they've done. And I hope they reverse it. I did get the first two cycles, like I said, but, uh, it was one was over the holidays, so it was lower. Anyway, um, I'm still in trouble though, because all my landlords at least gave us reprieve. Like January. They said, okay, we get it. But now on my biggest center, I owe \$100,000 in rent because I didn't pay January and I need February. That's \$100,000 right there that I don't have because I didn't get that. I'm behind 300. And so it's a catch up game that's going to be really hard to catch up on. I mean, I do have a little breathing room, like you said, it's not like I'm closing on Monday now, but it's not going to be an easy road unless they actually repair the damage that they're doing to us daily. Because every day I fall more behind.

You've been deeply involved in politics. It's one of the things when I met you, you were a founder of the Canary Party and attempt to sort of bring this autism issue into politics, to have politicians discussing it. You and I have gone to state capitals deeply involved with the Republican Party. I think I can say that you've been you know, I think your name is on enough things. I can say that safely. Was this a learning experience just about government? I mean, big government. And what happens? Is it hard to fix problems like this, like fraud? Um, or do you just think this is just total ineptitude?

**[01:10:32] Jennifer Larson, Founder and CEO, Holland Autism Center**

I'm just scared that it could happen again. You know, I mean, having a business, and it's interesting. And I try not to read comments on articles and things where things are posted that, you know, if you do rely on the government for its for me, it's 60% of what we bring in and they can just blanket pull it out like that from you. I just don't know if it's how I can feel comfortable going forward in an industry where that can happen. I don't know why it could happen again. They can just say, no, we're not going to pay you again. And. And then what do you do? Um, so I think, I think I what what it taught me is, um, well, it's taught me a lot, actually. And it scares me. It scares me a lot for Minnesota and a lot of the states, California and a lot of the blue states. Because, um, if anything can be learned from this for the states that haven't pulled their Medicaid is don't do what Minnesota did and don't shut down the real people who are servicing real children and real adults and have real disabilities don't do that. Do something else. If there's any lesson to be learned from this, regardless of what happens with me. But that's that's what I think. I think it's government, um, isn't paying attention to the people. And like, again, it wasn't it wasn't CMS that did this. It was Governor Walz that did this, and that keeps kind of getting confused, unfortunately.

Yeah, I didn't I'm glad we cleared that up because I didn't have that right. I was like, Bobby, where are you at? What are you doing? This is one of our.

I've been yelling. I've been Bobby I'm texting Bobby to. I'm like, come on, somebody help! Help me out here.

Speaking of Bobby, speaking of Bobby, let's move to, I think, probably the greatest headline of the week, um, is the new interagency, um, Autism Coordinating Committee. Sitting with you at that hearing behind you was your son, Caden. Um, who has been with you all along the way. He is now one of the members of a government agency that's going to be helping to decide where billions of dollars in funding around the autism issue is going to go. Uh, Caden Larson is a non-speaking adult with autism, is currently enrolled at Normandale Community College in Minnesota studying mathematics, serves as a board member of children with Autism Deserve Education, which connects families with grants for medical services education, therapy. Larson also works with communications for All and Spellers Freedom Foundation, which aimed to bring spelling and typing as a method of communication and education to socioeconomically challenged communities and public schools. This is one of the great stories of all time. I mean, you know, let's just talk about spellers for a second. You had a son. He would walk with you. I met him always. Beautiful, beautiful smile. But I didn't, you know. You know where I want to say. Was it 5 or 6 years ago? He. We didn't know what his communication level was or what his education level was. I don't want to misstate the amount of years we're in because I'm losing track of time. But describe Spellers where you were at with Cayden.

It's 2020 right when Covid was hitting when we started spelling. But um, prior to that, uh, you know, I always knew he was in there. I just couldn't reach him. I believed he was there, but he had no way to communicate. Even with an iPad. Even, you know, the buttons. He just never got it. Um, they thought he had the intellect of a four year old. That's what, you know, psych testing would tell me. Um, and so, no, you know, I spent 20 years just guessing what he wanted and, you know, and trying to make it through, um, and he's lovely. And and this is, uh, you know, spelling started in 2020, and, um, and, you know, this Dell has saved his life. And I was speaking with people about that, about his cancer in 2022. Um, but.

Tell us just a little bit. Because this is I mean, so he basically told you I'm having issues that you wouldn't have known otherwise, right? He was able to communicate.

**[01:14:38] Jennifer Larson, Founder and CEO, Holland Autism Center**

Well. He had some issues during his cancer that if he couldn't tell me, um, that weren't presenting a fever, that he would have died. And his oncologist is not saying that because he had infections that hurt. You know, to urinate and other things. And he. And if he couldn't tell me, mom, this, you know, I feel this way he would have died because he had no white count. Um, yeah. So, no, he he he, um. Yeah, he's a he's a trooper. And he is so proud, to be honest. You should have seen him this morning. He's so, so absolutely over the top. I couldn't be more proud also, but.

Yeah, well, it's an amazing story. It's a great team of people that that Bobby Kennedy has put together. There are so many of our friends that, you know, some great scientists, doctors, um, you know, there's there's many that I'm sure wish they could be on there. I want to say it is a dream team. There's some people like you out there, here in my own company that I wish were on that, but it's a really great step in the right direction. Uh, so as you look at this work that you've been doing, you're right there on the ground floor with children. You've taken care of your own. You've been involved in politics. Uh, what is your feeling now about what Kennedy is doing? Do you have hope that we're going to start seeing some light at the end of the tunnel on this journey?

Oh, 100%. I think Bobby's doing all the right things. I am supportive of everything he's done. I'm supportive of the people he's working with. I'm supportive of what they did for hep B, what they're going to, what they're doing with all the with the schedule, what he's done with the food pyramid. He's been doing amazing things that we all know for 20 years have been the right things to do. And finally, um, for those of us who've been screaming in the wind and, you know, victimized and, you know, called crazy, you know, tinfoil people. Hey, guess what? Like you were saying in your last segment, there's there's no proof. There's no proof. There's no double blind studies. All this. I'm so happy he's suing the Academy of Pediatrics. I know a doctor here in the Twin Cities who had to leave his practice because he, um, was being victimized by his practice, saying, if you don't do this, you're going to be fired. And so then he just left. So I think this is everything he's doing I 100% support I do have I do finally have hope. I just think the administration, we got to get through the midterms and we got to keep we've got to keep Bobby there. And we got to keep the power on the right side of the issues.

Doctors and scientists like Peter McCullough and Robert Malone are marching and stepping forward and saying, yeah, I would not touch this program with my kids. Get away. We never did the science. It's time for the science. This is what we're all about. And if you want to help spread the message, get your eyes cards. This is, you know, just go. If you're if you're watching, you can go to inconvenience Study.com. Really? Just buy a pack of these cards. This is a game changer. It makes it so easy for you to help spread the message. Just walk up to pregnant mom that's out there or family and just say, hey, have you ever like, are you possibly like thinking about vaccines or questioning? Here is a movie? I think that really moved me to study. That's, I think, really important. Very compelling. Check it out. Good luck. Take care. We're changing the world. The message is spreading every single day. We are moving the needle. You're a part of that every time you watch. You're a part of that every time you share. You're definitely a part of that. If you're helping sponsor and donate to the work that we're doing. Thank you for being you. Thank you for being a warrior of conscience. And I'll see you next week.
